#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-I in the area bounded by:

The public alley next north of and parallel to West Belden Avenue; the public alley next west of and parallel to North Western Avenue; West Belden Avenue; and a line 142.40 feet west of and parallel to North Western Avenue

to those of an RM-4.5 Residential Multi-Unit District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.





In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about April 19, 2023, the undersigned will file an application for a change in zoning from a RS-3 Residential Single-Unit (Detached House) District to an RM-4.5 Residential Multi-Unit District on behalf of 2412 Belden LLC (the "Applicant") for the property located at 2412 West Belden Avenue, Chicago, Illinois (the "Property"). The Property is bounded by:

The public alley next north of and parallel to West Belden Avenue; the public alley next west of and parallel to North Western Avenue; West Belden Avenue; and a line 142.40 feet west of and parallel to North Western Avenue

The subject property is improved with a two and half-story residential building containing four residential dwelling units in the front of the property and a two-story residential building at the rear of property with one residential dwelling unit and no parking. The Applicant seeks to add dormers to the front building to expand the size of the existing units in the front building. No expansion of the rear building is proposed.
