# ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 20-K in the area bounded by

West 81<sup>st</sup> Street; a line from a point 275 feet east of South Cicero Avenue and the south right-of-way line of West 81<sup>st</sup> Street; to a point, 280 feet east of South Cicero Avenue and 600 feet south of West 81<sup>st</sup> Street; a line 600 feet south of and parallel to West 81<sup>st</sup> Street; and South Cicero Avenue,

to those of a B3-2 Community Shopping District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.


