## **ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RM-5 Residential Multi-Unit District symbols and indications as shown on Map No. 10-E in the area bounded by

East Pershing Road; the alley next east of and parallel to South Dr. Martin Luther King Jr. Drive; a line 100 feet south of and parallel to East Pershing Road; and South Dr. Martin Luther King Jr. Drive,

to those of a C1-1 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.
