BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-3 Neighborhood Shopping District symbols and indications as shown on Map No. 3-G in the area bounded by

the alley next south of and parallel to West Blackhawk Street;
the alley next northeast of and parallel to North Milwaukee Avenue; a line 10.20 feet southeast of the east line of North Ashland Avenue, as measured along the northerly right-of-way line of North Milwaukee Avenue and perpendicular thereto; North Milwaukee Avenue; North Ashland Avenue; and a line 20.80 feet north of the intersection of North Milwaukee Avenue and North Ashland Avenue, as measured along the east right-of-way line of North Ashland Avenue and perpendicular to North Milwaukee Avenue,

to those of a B3-3 Community Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
