### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance,

is hereby amended by changing all the B1-3 Neighborhood Shopping District symbols

and indications as shown on Map No. 3-G in the area bounded by

the alley next south of and parallel to West Blackhawk Street; the alley next northeast of and parallel to North Milwaukee Avenue; a line 10.20 feet southeast of the east line of North Ashland Avenue, as measured along the northerly right-of- way line of North Milwaukee Avenue and perpendicular thereto; North Milwaukee Avenue; North Ashland Avenue; and a line 20.80 feet north of the intersection of North Milwaukee Avenue and North Ashland Avenue, as measured along the east right-of -way line of North Ashland Avenue and perpendicular to North Milwaukee Avenue,

to those of a B3-3 Community Shopping District and a corresponding uses district

is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage

This section defines each category of powers listed in the statutory short form power of attoruey for property and the effect of granting powers to an agent.
