Se It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to GINO'S EAST PIZZERIA upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 160-64 E. Superior St.. Said sidewalk cafe area #1 shall be twenty-five (25) feet in length and eleven point six seven (11.67) feet in width for a total of two hundred ninety-one point seven five (291.75) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along E. Superior Street. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday through Sunday 9:00 a.m. to 11:00 p.m. Compensation: \$671.03 SEATING CAPACITY: 18

Sidewalk Cafe Permit and approved plan must be posted at all times.

* Sidewalk Cafes shall not operate earlier than 8:00 AM, nor later than 11:00 PM.

This grant of privilege #1095133 for a sidewalk cafe shall be subject to the provisions of Section 10-28-900 though 10-28-995 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.


