COMMERCIAL VACATION ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the properties at 125-137 N. Ogden Avenue and 1422-1426 W. Washington Boulevard are owned by the Tuberculosis Institute of Chicago and Cook County ("Developer"); and

WHEREAS, the Developer proposes to use the portion of the alley remnant to be vacated herein for new building construction; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of that portion of the public alley described below; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1.

The vacation of:

THAT PART OF THE EAST-WEST 16 FOOT WIDE PUBLIC ALLEY LYING NORTH OF AND ADJOINING LOT 23 THROUGH 25 IN WEBSTER'S SUBDIVISION OF LOTS 6 TO 15 IN BLOCK 2 IN UNION PARK ADDITION TO CHICAGO, IN THE WEST HALF OF THE SOUTHWEST QUARTER OF SECTION 8, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, RECORDED APRIL 17 1875 PER DOCUMENT NUMBER 23595, AND DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHEAST CORNER OF LOT 25 AFORESAID, THENCE SOUTH 87 DEGREES 51 MINUTES 59 SECONDS WEST ALONG THE NORTH LINE OF LOTS 23, 24, AND 25 AFORESAID 67.50 FEET TO THE NORTHWEST CORNER OF SAID LOT 23, ALSO BEING THE TERMINUS OF A PORTION OF SAID 16 FOOT WIDE PUBLIC ALLEY PREVIOUSLY VACATED PER DOCUMENT NUMBER 18856859 RECORDED JULY 18, 1963; THENCE ALONG SAID TERMINUS NORTH 01 DEGREES 34 MINUTES 17 SECONDS WEST ALONG THE WEST LINE OF SAID LOT 23 PRODUCED NORTH 16.00 FEET TO A POINT ON THE SOUTH LINE OF LOT 8 IN WEBSTER'S SUBDIVISION OF LOTS 6 TO 15 IN BLOCK 2 AFORESAID; THENCE NORTH 87 DEGREES 51 MINUTES 59 SECONDS EAST ALONG THE SOUTH LINE OF LOTS 6, 7 AND THAT PART OF

LOT 8 IN WEBSTER'S SUBDIVISION OF LOTS 6 TO 15 IN BLOCK 2 AFORESAID 60.08 FEET TO THE MOST SOUTHERLY SOUTHEAST CORNER OF SAID LOT 6; THENCE NORTH 37 DEGREES 05 MINUTES 26 SECONDS EAST ALONG THE SOUTHEASTERLY LINE OF LOTS 5 AND 6 IN WEBSTER'S SUBDIVISION OF LOTS 6 TO 15 IN BLOCK 2 AFORESAID, 11.87 FEET TO POINT OF INTERSECTION WITH THE EAST LINE OF SAID LOT 25 EXTENDED NORTH; THENCE SOUTH 01 DEGREES 34 MINUTES 17 SECOND EAST ALONG THE NORTHERLY EXTENSION OF THE EAST LINE OF LOT 25 AFORESAID 25.20 FEET TO THE POINT OF BEGINNING, IN COOK COUNTY, ILLINOIS. SAID ABOVE DESCRIBED PARCEL CONTAINING 1,114 SQUARE FEET OR 0.025 ACRES, MORE OR LESS, as shaded and legally described by the words "HEREBY VACATED" on the plat hereto attached as EXHIBIT A, which plat for greater clarity, is hereby made a part of this ordinance, be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

SECTION 2. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, the Developer shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to the owner of the abutting of public allev hereby vacated sum property said part dollars (\$), which sum in the judgment of this body will be equal to such benefits.

SECTION 3. The vacation herein provided for is made under the express condition that the Developer, its successors and assigns, shall hold harmless, indemnify and defend the City of Chicago from all claims related to said vacation.

SECTION 4. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance the Developer shall file or cause to be filed for recordation with the Office of the Cook County Clerk / Recordings Division, a certified copy of this ordinance, together with the associated full-sized plat as approved by the Chicago Department of Transportation Superintendent of Maps and Plats.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication. The vacation shall take effect and be in force from and after recording of the published ordinance and approved plat.




