BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance,

is hereby amended by changing all the RS-3 Residential Single-Unit (Detached House)

District symbols and indications as shown on Map No. 3-I in the area bounded by

West Augusta Blvd.; a line 25.8 feet east of and parallel to North California Avenue; the alley next south of and parallel West Augusta Blvd.; and North California Avenue,

to those of a C1-3 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Floor Area Ratio: The floor area ration is 1.95.


Density: There are four dwelling units and the density per unit is 806 square feet per unit.
