ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 16-E in the area bounded by

South Rhodes Avenue; the public alley next northeast of and parallel to South South Chicago Avenue; a line 75 feet southeast of and parallel to South Rhodes Avenue; South South Chicago Avenue,

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.






The following Zoning analysis shall be included with the application to rezone 6817 through 6821 S. South Chicago Avenue (also known as lots 6, 7 and 8 on the attached survey) from a Zone M1-2 to a Zone C1-2. The space located at 6817 S. South Chicago covers all of lot 6 and part of lot 7 on the building's second floor. The building space located at 6819 S. South Chicago occupies the first floor of lots 6 and 7, and all of lot 8.


The total floor area ratio (FAR) of 6817 through 6821 S. South Chicago Avenue is 1.51. This is not a residential building and therefore it does not have a density requirement. The subject property has 14 off-street parking spaces proposed for an area located in an adjacent building less than 100' away. There are no front or side setbacks, but, a rear setback of 64 feet begins approximately 22 feet above grade. The highest point of the property is 31'-6". The floor-to-floor height is 14ft on the first floor and 12ft on the second floor. The front and side setbacks are non-existent and the rear setback is 64' beginning 18 feet above grade.

The property is currently unoccupied and was apparently once used for manufacturing purposes. If allowed to rezone this property to a C1-2, the client has expressed a desire to operate a banquet hall/meeting room facility in 6817 S. South Chicago of the property. See tables below.
