TRIBUTE TO THE LIFE OF ALEX DANIEL THOMAS

WHEREAS, Almighty God, in His Infinite Wisdom, has granted Alex Daniel Thomas etemal life on March 6, 2011; and

WHEREAS, Alex Daniel was bom in Cmger, Mississippi on March 13, 1923 and was the fourth child bom to Angus and Jencie Thomas. He was affectionately known as his "Momma's Baby". Alex attended Mt. Olive Grammar and High School in Mt. Olive Community of Lexington, Mississippi; and

WHEREAS, A devout Christian, Alex was a member of Mt. Olive Baptist Church at a young age and participated joyously with the congregation. He and the late Matilda McGee were united in Holy matrimony on December 24, 1942 and were blessed with four children, Janie, Marie, Delbert and Norman; and
