

The sign warrant payer shall keep the portion of area in, over, or adjacent to said privilege in good condition and repair, safe for public travel, free from snow, ice, and debris to the satisfaction of the City of Chicago. However the sign warrant payer understands the this request for an ordinance is subject to amendment, modification, or repeal, and permission and authority herein granted maybe revoked by the Mayor of the City of Chicago or the Director at their discretion, or at any time with the consent of the grantee. Upon termination the grantee without cost or expense to the City of Chicago, shall remove the structures herein authorized and restore the site to a proper condition under the supervision and satisfaction of the City. The grantee shall keep harmless the City of Chicago, against all claims, liabilities, judgments, cost, damages, to or recovered from the City of Clicago, in consequence of the permission given by this ordinance, or any act or thing done or omitted or neglected to be done by the grantee, its agents, or employees in and about the construction, maintenance, or operation of the sign.

We humbly seek the privilege of an ordinance to install a sign that will read "Reggio's Pizza We Deliver 312-4S5-1Z11 that is a total of 152 square feet of total area and the overall height of 39'-0" feet above finished grade. 
