ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 5-G in the area bounded by

The public alley next south of and parallel to West Armitage Avenue; a southwesterly line 65.30 feet long perpendicular to North Maud Avenue starting at a point 92.30 feet east of the northeast boundary line of North Maud Avenue (as measured along the south line of the public alley next south of and parallel to West Armitage Avenue) and ending at a point 65.41 feet southeast of the south line of the public alley next south of and parallel to West Armitage Avenue) and ending at a point 65.41 feet southeast of the south line of the public alley next south of and parallel to West Armitage Avenue (as measured along the northeast boundary line of North Maud Avenue); North Maud Avenue,

to those of an RM5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about June 2, 2011, the undersigned, as the owner of the property, will file an application for a change in zoning from RT-4 to RM5 for the property located at 1975 N. Maud Avenue, Chicago, Illinois to increase the maximum allowable Floor Area Ratio to allow for the construction of a 722 square foot, 2 story, 24 foot high, masonry addition to the existing 3 story masonry single family residence. The existing residence currently exceeds the maximum allowable Floor Area Ratio for RT-4 zoning.

After the addition is constructed, the property zoning will be changed back to the original RT-4 zoning. The applicant/owner intends to continue to use the subject property as a single family residence after the addition is constructed.

If the City determines that any information provided in this EDS is false, incomplete or inaccurate, any contract or other agreement in connection with which it is submitted may be rescinded or be void or voidable, and the City may pursue any remedies under the contract or agreement (if not rescinded, void or voidable), at law, or in equity, including terminating the Disclosing Party's participation in the Matter and/or declining to allow the Disclosing Party to participate in other transactions with the City. Remedies at law for a false statement of material fact may include incarceration and an award to the City of treble damages.

E. It is the City's policy to make this document available to the public on its Internet site and/or upon request. Some or all of the information provided on this EDS and any attachments to this EDS may be made available to the public on the Internet, in response to a Freedom of Information Act request, or otherwise. By completing and signing this EDS, the Disclosing Party waives and releases any possible rights or claims which it may have against the City in connection with the public release of information contained in this EDS and also authorizes the City to verify the accuracy of any information submitted in this EDS.

F. The information provided in this EDS must be kept current. In the event of changes, the Disclosing Party must supplement this EDS up to the time the City takes action on the Matter. If the Matter is a contract being handled by the City's Department of Procurement Services, the Disclosing Party must update this EDS as the contract requires.

The Disclosing Party represents and warrants that:

G. The Disclosing Party has not withheld or reserved any disclosures as to economic interests in the Disclosing Party, or as to the Matter, or any information, data or plan as to the intended use or purpose for which the Applicant seeks City Council or other City agency action.


