ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home mle unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and as such, may exèrcise any power and perform any function pertaining to its government and affairs; and

WHEREAS, by ordinance adopted by the City Council of the City (the "City Council") on March 12, 1986, and published in the Journal of the Proceedings of the City Council (the "Journal") for such date at pages 28534-28536 (the "Disposition Ordinance"), the City Council authorized the conveyance to S. Gordon and Sons, Inc., an Illinois corporation which was involuntarily dissolved by the Illinois Secretary of State on May 1, 1997 (the "Original Developer"), of certain real property generally located in the south half of the 1600 block of South Canal Street and the 1700 block of South Canal Street, Chicago, Illinois, and legally described in <u>Exhibit A</u> attached hereto (the "Disposition Property"); and

WHEREAS, the City and Original Developer entered into a Contract for the Sale of Land and Redevelopment, dated on or as of August 27, 1986, and recorded with the Office of the Recorder of Deeds of Cook County, Illinois (the "Recorder's Office) on November 7, 1989, as document number 89530244 (the "Redevelopment Agreement"); and

WHEREAS, in accordance with the Disposition Ordinance and the Redevelopment Agreement, the City conveyed, pursuant to two (2) quitclaim deeds (collectively, the "Deeds") each dated December 30, 1986, and recorded with the Recorder's Office on December 31, 1986 and January 31, 1989, as document numbers 86628753 and 89848321, the Disposition Property to the Original Developer; and

WHEREAS, the Disposition Property is encumbered with various covenants (the "Covenants") mnning with the land, as set forth in the Redevelopment Agreement and the Deeds, including the requirement to construct certain improvements; and

WHEREAS, neither the Original Developer nor subsequent titleholders to the Disposition Property constructed any improvements on the Disposition Property and the Disposition Property currently is vacant; and

WHEREAS, Millennium East L.L.C., an Illinois limited liability company ("MELLC"), is in title to that portion of the Disposition Property legally described in <u>Exhibit B</u> attached hereto (the "Millennium-Owned Property"); and

WHEREAS, MELLC has requested that the City release the Covenants from the Millennium-Owned Property; and

WHEREAS, pursuant to an ordinance adopted by the City Council on June 10, 1998 and published at pages 70521 through 70685, in the Journal of such date, a certain redevelopment plan and project ("Redevelopment Plan") for the Pilsen Tax Increment Financing Redevelopment

Project Area ("Redevelopment Area"), was approved pursuant to the Illinois Tax Increment Allocation Redevelopment Act, as amended (65 ILCS 5/11-74.4-1 et seq.) (the "Act"); and

WHEREAS, pursuant to an ordinance adopted by the City Council on June 10, 1998 and published at pages 70685 and 70687 through 70699 in the Journal of such date, the Redevelopment Area was designated as a redevelopment project area pursuant to the Act; and

WHEREAS, pursuant to an ordinance adopted by the City Council on June 10, 1998 and published at pages 70700 through 70712 in the Journal of such date, tax increment financing was adopted pursuant to the Act as a means of financing certain Redevelopment Area redevelopment project costs (as defined in the Act) incurred pursuant to the Redevelopment Plan; and

WHEREAS, the Redevelopment Plan and the use of tax increment financing provide a mechanism to support new growth through leveraging private investment, and helping to finance land acquisition, demolition, remediation, site preparation and infrastructure for new development in the Redevelopment Area; and

WHEREAS, the Disposition Property is located in the Redevelopment Area; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

<u>SECTION 1</u>. The foregoing recitals are hereby adopted as the findings of the City Council.

SECTION 2. The City's releasing the Millennium-Owned Property from the Covenants in exchange for MELLC's paying the City such amount as may be acceptable to the Commissioner of the Department of Housing and Economic Development (the "Commissioner"), in the Commissioner's sole discretion, is hereby approved; provided that any such release shall be subject to the execution and recording of a new redevelopment agreement approved by City Council governing the development of the Millennium-Owned Property which shall be consistent with the Redevelopment Plan and imposing new development covenants applicable to MELLC's new development.

SECTION 3. The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a release consistent with Section 2 above.

<u>SECTION 4.</u> If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

<u>SECTION 5.</u> All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 6. This ordinance shall take effect immediately upon its passage and approval.
