# **ORDINANCE**

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by

North Milwaukee Avenue; a line 375 feet northwest of the northwesterly line of North Honore Street; the public alley next south of and parallel to North Milwaukee Avenue; and a line 425 feet northwest of the northwesterly line of North Honore Street,

to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.

In accordance with Section 11.10-3 of the Zoning Ordinance, Title 17 of the Municipal Code of Chicago, please be informed that on or about June 1, 2011, 1552 Milwaukee, LLC will file an application with the Department of Housing and Economic Development of the City of Chicago for a change in zoning from a B3-2 Community Shopping District to a B3-3 Community Shopping District for the property commonly known as 1552 N. Milwaukee Avenue (the "Property").




