
TO THE PRESIDENT AND MEMBERS OF THE CITY COUNCIL:

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO**

**SECTION 1.** That the Commissioner of Buildings, Executive Director of Construction and permits, the Commissioner of Streets and Sanitation, the Commissioner of Transportation, the Commissioner of Water management, the Commissioner of Fire, and the Director of the Department of Revenue are hereby authorized and directed to issue all necessary special event permits and licenses, free of charge notwithstanding other ordinances of the City of Chicago to the contrary.
