A line 283 feet South of and parallel to West 53<sup>rd</sup> Street; South Monitor Avenue; a line 316 feet South of and parallel to West 53<sup>rd</sup> Street; a public alley next West of and parallel to South Monitor Avenue.

To those of an RT3.5, Residential Two-Flat, Townhouse and Multi-Unit District






