Repeal Standing Zone

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Repeal ordinance passed 7-29-2003 page #5750 which reads, North LaSalle Street (east side) from a point 20 feet north of West Superior Street, to a point 25 feet north thereof—15 minute standing zone – unattended vehicles must use flashing lights – 9:00a.m. to 4:00p.m. – Monday through Friday.

SECTION 2. This ordinance shall take effect and be in force hereinafter its passage and publication.

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Pursuant to Title 9, Chapter 64 of the Municipal Code of Chicago, the following locations are hereby designated as traffic lane tow-away zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

42	West Lake Street (south side) from a point 40 feet east of North Wacker Drive, to a point 20 feet east thereof reserved disabled parking/tow-away zone (2%) (03-00962149);
	South Jefferson Street (west side) from a point 87 feet south of West Adams Street, to a point 70 feet south thereof 15 minute standing zone use flashing lights 7:00 A.M. to 5:00 P.M Monday through Friday tow-away zone (03-00962262);
42 .	West Ohio Street (south side) from a point 70 feet west of North Wells Street, to a point 35 feet west thereof 30 minute standing zone use flashing lights 9:30 A.M. to 4:00 P.M Monday through Friday and 9:00 A.M. to 5:00 P.M Saturday and Sunday tow-away zone (03-00742401);
42	North LaSalle Street (east side) from a point 20 feet north of West Superior Street, to a point 25 feet north thereof 15 minute standing zone unattended vehicles must use flashing lights 9:00 A.M. to 4:00 P.M Monday through Friday.

SECTION 2. This ordinance shall take effect and be in force hereinafter its passage and publication.
