#### ORDINANCE

WHEREAS, the City of Chicago ("City") a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and as such, may exercise any power and perform any function pertaining to its government and affairs; anc

WHEREAS, the ("City"), is the owner of the vacant parcels of property located at 1209 E. 79<sup>th</sup> Street and 7901 S. Woodlawn Avenue, Chicago, Illinois, which are legally described on Exhibit A attached hereto ("Property"), which Property is located in the 71<sup>st</sup> and Stony Island Tax Increment Financing Area ("Area") established pursuant to ordinances adopted by the City Council of the City on October 7, 1998, published in the Journal of Proceedings of the City Council for such date at pages 78139 through 78242; and

WHEREAS, Harold Harvey ("Grantee"), 4228 Pinewood Lane, Matteson, Illinois, 60443, has offered to purchase the Property from the City for the sum of Sixteen Thousand Seven Hundred Fifty and No/100 Dollars (\$16,750.00), such amount being the appraised fair market of the Property with a parking lot in perpetuity deed restriction, for the purpose of constructing a parking lot thereon; and

WHEREAS, public notice advertising the City's intent to enter into a negotiated sale of the Property with the Grantee and requesting alternative proposals appeared in the *Chicago Sun-Times*, a newspaper of general circulation, on February 21, 2011, and February 28, 2011; and

WHEREAS, no alternative proposals were received by the deadline indicated in the aforesaid notice; now, therefore

WHEREAS, pursuant to Resolution No. 11-032-21 adopted on March 17, 2011, by the Plan Commission of the City of Chicago ("Commission"), the Commission approved the sale of the Property to the Purchaser; now, therefore

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** The City Council hereby approves the sale of the Property to the Grantee in the amount of Sixteen Thousand Seven Hundred Fifty and No/100 Dollars (\$16,750.00).

**SECTION 2.** The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a quitclaim deed conveying the Property to the Grantee. Such deed shall include a covenant obligating the Grantee to use the Property only for a use consistent with the land uses permitted under the redevelopment plan for the Area. Grantee's acceptance of the City's deed shall constitute Grantee's agreement to such covenant. The quitclaim deed shall contain language substantially in the following form:

This conveyance is subject to the express conditions that: 1) a parking lot is constructed on the Property within twelve (12) months of the date of this deed; and 2) the Property is thereafter maintained and used as a parking lot in perpetuity. In the event that the conditions are not met, the City of Chicago of may re-enter the Property and revest title in the City of Chicago. Grantee, at the request of the City of Chicago, covenants to execute and deliver to the City a reconveyance deed to the Property to further evidence such revesting of title.

This right of reverter and re-entry in favor of the City shall terminate forty (40) years from the date of this deed.

Grantee's acceptance of such quitclaim deed shall be deemed to be Grantee's agreement to comply with such redevelopment obligations.

**SECTION 3.** If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity of such provision shall not effect any of the other provisions of this ordinance.

**SECTION 4.** All ordinances, resolutions, motions or orders inconsistent with this ordinance are hereby repealed to the extent of such conflict.

**SECTION 5.** This ordinance shall take effect upon its passage and approval.
