**SUBSTITUTE**  
**ORDINANCE**

**SECTION 1.** Section 2-30-030 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as follows:

**2-30-030 Commissioner - Powers and duties designated.**

The commissioner of the environment shall have the following powers and duties:


(1) To supervise the execution of and implement all laws, ordinances, rules and regulations pertaining to environmental protection and control as provided in Chapter 11-4 of the Municipal Code of Chicago;

(21) To enter into grant agreements, cooperation agreements and other agreements or contracts with governmental entities, private business and civic and community groups necessary to implement ~~the Green Streets Program and other urban forestry, beautification and environmental enhancement and protection programs including but not limited to ; and~~ agreements to implement the Green Streets Program and other urban forestry or beautification programs, the State of Illinois Site Remediation Program and other programs to remediate contaminated sites, and pharmaceutical and other waste disposal programs, and to enter into and execute all such other instruments and to perform any and all acts, including the expenditure of funds subject to appropriation therefor, as shall be necessary or advisable in connection with the implementation of such agreements, including any renewals thereto.

**SECTION 2.** This ordinance shall be in force and effect upon passage and publication.


