ORDINANCE ST ALOYSIUS CATHOLIC CHURCH Acct No 276228 - 3 Permit No 1097425

Be It Ordained by the City Council of the City of Chicago

SECTION 1 Permission and authority are hereby given and granted to ST ALOYSIUS CATHOLIC CHURCH, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use eight (8) Canopies (Sun Shades) projecting over the public right-of-way adjacent to its premises known as 1510 N Claremont Ave

Said Canopies (sun shades) at N Claremont measure(s)

Four (4) at seventeen point nine two (17 92) feet in length, and two (2) feet in width for a total of one hundred fortythree point three six (143 36) square feet. Said sun shades shall be approximately nineteen (19) feet above grade level

Said Canopies (sun shades) at N Claremont measure(s)

Four (4) at seventeen point nine two (17 92) feet in length, and two (2) feet in width for a total of one hundred fortythree point three six (143 36) square feet. Said sun shades shall be approximately thirty-one (31) feet above grade level

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department -Signs

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago

The grantee shall pay to the City of Chicago as compensation for the privilege #1097425 herein granted the sum of four hundred (\$400 00) per annum in advance

A 25% penalty will be added for payments received after due date

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way

Authority herein given and granted for a period of five (5) years from and after Date of Passage
