SECTION 1 Permission and authority are hereby given and granted to QUSAI AND DENISE MAHMUD, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Fence(s) on the public right-of-way adjacent to ts premises known as 1710 S Laflin St

Said Fence(s) at LAFLIN measure(s)
One (1) at sixty-six point eight three (66 83) feet in length, and one (1) foot in width for a total of sixty-six point eight three (66 83) square feet

The locatıon of said privilege shall be as shown on prints kept on file with the Department of Businéss Affairs and Consumer Protection and the Office of the City Clerk

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development)
