ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City and GD 22 W. Washington LLC, a Delaware limited liability company ("Developer"), have previously entered into that certain Limited Joinder to 108 North State Street Redevelopment Agreement dated as of October 20, 2006 and recorded in the Recorder's Office of Cook County ("Recorder's Office") on November 6, 2006 as document no. 063104113 (the "Limited Joinder"), which limited joinder was entered into in furtherance of the 108 North State Street Redevelopment Agreement by and between the City and Block 37, L.L.C., a Delaware limited liability company, dated as of October 15, 2005 and recorded in the Recorder's Office on November 14, 2005 as document no. 0531834078 (as amended, the "Block 37 RDA"); and

WHEREAS, pursuant to the Limited Joinder, the Developer has previously completed construction of the APP Project (as defined in the Limited Joinder), consisting of certain subgrade improvements, certain streetscape improvements and construction of a [nineteen (19)] story office building currently occupied by CBS and Morningstar; and

WHEREAS, the City has issued its APP Certificate (as defined in the Limited Joinder) for the APP Project certifying as to such completed construction; and

WHEREAS, in view of the City's issuance of the APP Certificate, and in order to facilitate the possible resale and refinancing of the APP Project, the Developer has requested that the Department of Housing and Economic Development ("DHED") consent to a limited amendment to the Limited Joinder to eliminate certain sale and financing restrictions; and

WHEREAS, because construction of the APP Project has been completed, and because the APP Project is now separately owned and operated apart from the remainder of the Block 37 mixed-use project, the City's need to approve the sale and financing of the APP Project is no longer essential; and

WHEREAS, notwithstanding such limited amendment to the Limited Joinder, the other executory terms of the Limited Joinder shall otherwise remain in full force and effect; and

WHEREAS, because the City will realize significant real estate transfer tax revenues as a result of a sale of the APP Project, the City also has an interest in facilitating the transferability of the APP Project and in amending the Limited Joinder; now, therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are incorporated herein and made a part hereof and

represent the findings of the City Council with respect to the matters described therein.

SECTION 2. Notwithstanding the definitions of "Approved Purchaser" or "Permitted Transfer" (as such terms are defined in the Block 37 RDA, and incorporated in the Limited Joinder by reference), nor anything in the Limited Joinder to the contrary, the Developer (and its successors and assigns) shall be entitled to (a) sell, convey, transfer, lease or otherwise dispose of the APP Project, provided that all required real property transfer taxes are paid in connection with such sale, conveyance, transfer, lease or other disposition, and (b) finance (and refinance) such APP Project or the entity owning the APP Project, including the granting of a mortgage or mortgages, liens on beneficial or equity interests, or other liens secured by the APP Project or the equity interests therein, in each instance without obtaining the consent of DHED under the Limited Joinder to such sale, conveyance, transfer, lease or other disposition, or such financing (or refinancing).

SECTION 3. The following provisions of the Limited Joinder shall be amended as follows: (a) the financial statement reporting requirements in Section 8.01(j) and Section 8.12 shall be eliminated; (b) the cross-default covenant in section 8.01(i), which would make, under certain circumstances, a default under any Developer indebtedness or APP Project indebtedness a default under the Limited Joinder, shall be eliminated; and (c) the Developer shall be deemed to be in compliance with its insurance obligations under the Limited Joinder so long as it is in compliance with the insurance requirements of any lender providing financing to the Developer or with respect to the APP Project, so long as the City is named as additional insured under any liability policies and a certificate holder for notice purposes.

SECTION 4. The Commissioner of DHED (together with any successor to the duties of such commissioner, the "Commissioner") and a designee of the Commissioner are each hereby authorized, with the approval of the City's Corporation Counsel as to form and legality, to negotiate, execute and deliver an amendment to the Limited Joinder in recordable form setting forth the terms of Section 2 and Section 3 of this ordinance, and such other supporting documents as may be necessary to carry out and comply with the provisions of this ordinance.

SECTION 5. Except as amended by Section 2 and Section 3 of this ordinance, the Continuing Requirements (as defined in the Limited Joinder), and all representations, warranties and covenants contained in the Continuing Requirements, shall remain in full force and effect and be binding upon the Developer (and its successors and assigns), as described in Section 7.02(a) of the Limited Joinder.

SECTION 6. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 7. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 8. This ordinance shall be in full force and effect immediately upon its passage and approval.
