ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Planned Development No. 136 symbols in Subarea A as shown on Map No. 3-F for the property located in the area generally bounded by

West Division Street; a line 285.93 feet east of the CTA right-of-way; a line 95.20 feet south of and parallel to West Division Street extended in a southeasterly direction to a point 95.37 feet south of and parallel to West Division Street; a line 209.92 feet west of and parallel to North Wells Street; West Division Street; North Wells Street; West Hill Street; and the CTA right-of-way

to the designation of C1-5, Neighborhood Commercial District.

SECTION 2. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-5 symbols as shown on Map No. 3-F in the area described above in Section 1 of this Ordinance, and by changing all of the Planned Development No. 136 symbols as shown on Map No. 3-F to the designation of Planned Development No. 136, as amended, subject to the use and bulk regulations set forth in the Plan of Development attached hereto and made a part hereof.

SECTION 3. This ordinance takes effect after its passage and approval.

In accordance with the notice requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about November 2, 2011, an application for an Amendment to the Chicago Zoning Ordinance will be filed on behalf of the Applicant, Atrium Village Associates, for the property designated as Subarea A in Planned Development No. 136, generally bounded by West Division Street; North Wells Street; West Hill Street; and the CTA right-of-way, commonly known as 300 West Hill Street.

The Applicant, Atrium Village Associates, seeks to amend Subarea A of existing Planned Development No. 136 by first changing the zoning to C1-5, Neighborhood Commercial District, and then to the designation of Planned Development No. 136, as amended. The Applicant proposes to redevelop the existing Atrium Village complex to include approximately 1,500 dwelling units; approximately 32,750 square feet of retail space; approximately 1,280 parking spaces; an approximately 2-acre open space; and a new Bright Horizons daycare facility. It is contemplated that the improvements in Subarea A will be constructed in phases over a period of years.






Planned Development No. 136 Phase II - North Elevation






Planned Development No. 136 Phase II - South Elevation






Planned Development No. 136 Phase II - West Elevation


Planned Development No. 136 Phase III - East Elevation






Planned Development No. 136 Phase III - North Elevation






Planned Development No. 136 Phase III - South Elevation




Planned Development No. 136 Phase IV - East Elevation







Planned Development No. 136 Phase IV - North Elevation







Planned Development No. 136 Phase IV - South Elevation







Planned Development No. 136 Phase IV - West Elevation






Planned Development No. 136 Phase V - East Elevation







Planned Development No. 136 Phase V - North Elevation


Planned Development No. 136 Phase V - South Elevation








Planned Development No. 136 Phase V - West Elevation

Plan of Development Statements

- 1. The area delineated herein as Planned Development No. 136, as amended (the "Planned Development"), consists of approximately 370,040 square feet (8.49 acres) of property (the "Property"). The Planned Development includes two subareas, Subarea A and Subarea B. It is the intent of this ordinance to amend Subarea A only. Subarea A is under the single-designated control of Atrium Village Associates (the "Applicant").
- 2. All applicable official reviews, approvals or permits are required to be obtained by the owner(s) of the individual subareas or their successors, assignees or grantees. Any dedication or vacation of streets, alleys, easements or adjustments of rights-of-way, or consolidation or resubdivision of parcels, shall require a separate submittal on behalf of the owner(s) of the individual subareas or their successors, assignees or grantees and approval by the City Council.
- 3. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the owner(s) of the individual subareas, their successors and assigns and the legal titleholders and any ground lessors. All rights granted hereunder to the owner(s) of the individual subareas shall inure to the benefit of the owner('s') successors and assigns, the legal titleholder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time any application for an amendment, modification or change (legislative, administrative or otherwise) to this Planned Development is made, shall be under single ownership or single designated control. "Single designated control" is defined in Section 17-8-0400 of the Chicago Zoning Ordinance. The Subareas herein shall be deemed specifically delineated subareas and subparcels for purposes of Section 17-8-0400.

Nothing herein shall prohibit or in any way restrict the alienation, sale or any other transfer of all or any portion of the Property or any rights, interests or obligations therein by the owner(s) of the individual subareas and their successors, assigns and grantees, nor interfere with, abrogate or annul any zoning rights agreement, deed restriction or covenant, or other written agreement among owners (or owners' successors, assigns or grantees). Upon any alienation, sale or any other transfer of all or any portion of the Property or the rights therein (other than an assignment or transfer of rights pursuant to a mortgage or otherwise as collateral for any indebtedness) and solely with respect to the portion of the Property so transferred, the term "owner" shall be deemed amended to apply to the transfere thereof.

Where portions of the improvements located on the Property have been submitted to the Illinois Condominium Property Act, the term "owner" shall be deemed to refer solely to the condominium association of the owners of such portions of the improvements and the applicable portion of the Property, and not to the individual unit owners therein. An agreement among the different owners of the Property, or a covenant binding upon owners of the Property, may designate the parties authorized to apply for future amendments, modifications or other changes to this planned development.

4. This Planned Development consists of these nineteen (19) statements; a Bulk Regulations and Data Table; and the following exhibits prepared by Fitzgerald Associates Architects and Bumgardner Architecture dated November 2, 2011: an Existing Land Use Map; a Property Line Map and Right-of-Way Adjustment Map; an Existing Zoning Map; a Generalized Site Plan; a Ground Floor Plan; a Landscape Plan; a Green Roof Plan; and Proposed Elevations for the buildings in Phases I, II, III, IV and V.

Full-size copies of the exhibits are on file with the Department of Housing and Economic Development. This Planned Development conforms to the intent and purpose of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago, and all requirements thereof and satisfies the established criteria for approval as a planned development. In any instance where a provision of the Planned Development conflicts with the Chicago Building Code, the Building Code shall control, except as to measurement of height.

5. The following uses shall be permitted within Subarea A as delineated in Planned Development No. 136, as amended, subject to the restrictions in these statements and the Bulk Regulations and Data Table: residential dwelling units; day care facilities; schools; retail sales; accessory and non-accessory parking; restaurants (Limited and General); all Allowed uses in the C1, Neighborhood Commercial District; and accessory uses.

The following uses shall be permitted within Subarea B as delineated in Planned Development No. 136, as amended, subject to the restrictions in these statements and the Bulk Regulations and Data Table: residential dwelling units; community centers; day care facilities; religious assembly facilities, including accessory offices; accessory and non-accessory parking; and accessory uses.

- 6. On-premise signs and temporary signs are permitted within the Planned Development subject to the review and approval of the Department of Housing and Economic Development. Off-premise signs shall be prohibited.
- 7. Closure of all or part of any public streets or alleys during demolition or construction shall be subject to the review and approval of the Chicago Department of Transportation. All work proposed in the public way must be designed and constructed in accordance with the Chicago Department of Transportation Construction Standards for Work in the Public Way in effect at the time of construction and in compliance with the Municipal Code of the City of Chicago. Ingress and egress shall be subject to the review and approval of the Department of Transportation and the Department of Housing and

Economic Development. Off-street parking and loading facilities shall be provided in compliance with this Planned Development. A minimum of two percent (2%) of all parking spaces provided in Subarea A pursuant to this Planned Development shall be designated and designed as accessible parking for people with disabilities.

- 8. The maximum permitted floor area ratio ("FAR") for the Property shall be in accordance with the attached Bulk Regulations and Data Table. For purposes of floor area and floor area ratio calculations, the definitions contained in the Chicago Zoning Ordinance in effect as of the date of approval of this Planned Development shall apply.
- 9. The height of any building and any appurtenance thereto shall not exceed the height established within the Bulk Regulations and Data Table and shall also be subject to height limitations approved by the Federal Aviation Administration. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply.
- 10. The requirements of this Planned Development as they apply to a specific subarea may be modified administratively by the Zoning Administrator upon written application by the owner(s) of the subarea and a determination by the Zoning Administrator that the requested modification is minor, appropriate and consistent with the nature of the improvements contemplated by this Planned Development and the purposes underlying the provisions hereof. Any such modification of the requirements of this Planned Development by the Zoning Administrator shall be deemed to be a minor change in the Planned Development as contemplated by Section 17-13-0611-A of the Chicago Zoning Ordinance.
- 11. The Improvements on the Property shall be designed, constructed and maintained in substantial compliance with the exhibits attached hereto and with the landscaping and screening provisions of the Chicago Zoning Ordinance and corresponding regulations and guidelines.
- 12. Pursuant to Section 2-45-110 of the Municipal Code, the "Affordable Requirements Ordinance" (the "ARO"), an amendment to a Planned Development which grants additional floor area for the development of 10 or more housing units and/or for which the developer is receiving financial assistance from the City, subjects the development of the additional housing units authorized or permitted by such amendment to the affordability requirements specified under the ARO. As a result of this amendment to Planned Development No. 136, the City Council has approved additional floor area that authorizes or permits the development of 10 or more units. Ten percent (10%) of any housing units developed as part of the Planned Development are required to be built as affordable housing, as that term is defined by the ARO. As part of the approval process for any application proposing the construction of residential dwelling units, the Applicant shall also provide, for the review and approval of the Department of Housing and Economic Development (or any successor department thereto), such information, documents and agreements as may be required under the ARO to ensure that such required affordable housing units are provided and maintained.

- 13. The Applicant acknowledges that it is in the public interest to design, construct and renovate all buildings in a manner that provides healthier environments, reduces operating costs and conserves energy and resources. All new buildings within Subarea A shall be Certified under the Leadership in Energy and Environmental Design ("L.E.E.D.") Green Building Rating System and shall include a green roof which covers a minimum of 50% of each building's net roof area. All buildings constructed in Subarea A pursuant to this Planned Development shall conform to the City of Chicago Sustainable Development Policy Matrix (the "Matrix") in effect on the date of approval of this Planned Development.
- 14. It is in the public interest to design, construct and maintain the improvements on the Property in a manner which promotes, enables, and maximizes universal access throughout the Property. Plans for all newly constructed buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities ("M.O.P.D.") to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
- 15. Upon Part II Review, a Part II Review Fee shall be assessed by the Zoning Administrator pursuant to Section 17-13-0610 of the Chicago Zoning Ordinance. The fee as determined by staff at the time is final and binding on the Part II applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
- 16. It is contemplated that the improvements within Subarea A of this Planned Development will be constructed in phases and that all proposed buildings will not be fully designed at the time of the Planned Development's passage and approval. Accordingly, for the improvements in Subarea A not reviewed and approved by the Chicago Plan Commission, Site Plan Review shall be required for each proposed improvement. Review and approval of the Site Plan by the Zoning Administrator is intended to ensure that specific development proposals conform to this Planned Development and are compatible with the character of the improvements of this Planned Development.

A Site Plan submitted to the Zoning Administrator for review and approval shall, at a minimum, illustrate the following information:

- Elevations of the proposed building façades;
- Building orientation and setbacks;
- Building bulk and scale in relation to nearby buildings;
- Sidewalks and curb cuts;
- Parking and loading areas;
- Landscaping, lighting and signs;
- Conformance with the City of Chicago's Sustainable Development Policy;
- Information regarding the proposed building including floor area, FAR, proposed uses and building height; and

• Building materials.

The Zoning Administrator must review the Site Plan and issue a decision within thirty (30) days of receipt of the complete Site Plan whether the proposed plans conform to the character and requirements of this Planned Development. If the Zoning Administrator fails to issue a decision within thirty days, the Site Plan shall be deemed to be approved.

In the event of an inconsistency between the approved Site Plan and the Plan of Development Statements or the Bulk Regulations and Data Table of this Planned Development, the Plan of Development Statements and Bulk Regulations and Data Table shall govern.

- 17. Each developer of any portion of the Property at the time of a project shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioner of the Department of Streets and Sanitation, the Commissioner of the Environment and the Commissioner of Buildings pursuant to Section 13-32-125 of the Municipal Code of the City of Chicago or any other provision of that Code.
- 18. The Applicant acknowledges that the City of Chicago and the Chicago Transit Authority ("CTA") are studying the possibility of a future CTA station near West Division and North Orleans Street adjacent to the Property. At such time as the CTA or its designee initiates construction of the station, the Applicant agrees to work with the CTA to facilitate design and construction of the station adjacent to the Property. All costs associated with the construction of the station shall be borne by the CTA.
- 19. This Planned Development ordinance will lapse and be null and void unless construction within Subarea A of the Phase I Improvements as set forth in the attached Exhibits and as authorized by a building permit, has commenced within six years of the date of City Council approval. The six year period may be extended by up to one additional year if, before expiration, the Zoning Administrator receives a written request from the owner(s) of Subarea A and determines that good cause for an extension is shown. If this Planned Development amendment shall lapse as provided in this section, then the Zoning Administrator must initiate a Zoning Ordinance Map Amendment to rezone the Property to the zoning classification that applied to the Property before approval of this amendment.






Planned Development No. 136 Existing Land-Use Area Map





Planned Development No. 136 Ground Floor Plan





Planned Development No. 136 Landscape Plan






Planned Development No. 136 Green Roof Plan






Planned Development No. 136 Phase I - East Elevation




Planned Development No. 136 Phase I - North Elevation






Planned Development No. 136 Phase I - South Elevation


Planned Development No. 136 Phase I - West Elevation


Planned Development No. 136 Phase II - East Elevation






Planned Development No. 136 Phase II - North Elevation





Planned Development No. 136 Phase II - South Elevation






Planned Development No. 136 Phase II - West Elevation




