BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: That the Chicago Zoning Ordinance be amended by changing all the Institutional Planned Development No. 842 symbols and designations as shown on Map No. 2-F in the area bounded by

West Monroe Street; the alley next west of and parallel to South Desplaines Street; a line 71.40 feet South of and parallel to West Monroe Street; South Desplaines Street; West Adams Street; the easterly right-of-way line of the John Fitzgerald Kennedy Expressway (also known as a line 219.50 feet west of and parallel to South Desplaines Street); West Adams Street; the alley next east of and parallel to South Desplaines Street; the alley next south of and parallel to West Adams Street and South Desplaines Street,

to the designation of Institutional Planned Development No. 842, as amended, which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development herewith attached and made a part thereof and to no others.

SECTION 2: This Ordinance shall be in force and effect from and after its passage and due publication.







In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about October 21, 2011, I, the undersigned attorney, will file an application for a change in zoning from the Institutional Planned Development No. 842 to the Institutional Planned Development No. 842, as amended, on behalf of the Applicant for the property located at 601-31 W. Adams Street and 201-41 S. DesPlaines Street, Chicago, Illinois and bounded by West Adams Street; the alley next east of and parallel to South DesPlaines Street; the alley next south of and parallel to West Adams Street and South DesPlaines Street.

The purpose of the proposed amendment is to redevelop the property with a 22 story commercial building with a height of 336 feet containing office space, retail space, assembly and multi purpose space for Old St. Pats Church and 408 on site parking spaces.

INSTITUTIONAL PLANNED DEVELOPMENT NO. 842, AS AMENDED  
PLAN OF DEVELOPMENT STATEMENTS

1. The area delineated herein as Institutional Planned Development No. 842, as amended, consists of property located in Sub-Area A commonly known as 106-38 S. DesPlaines Street and 700-18 W. Adams Street and property located in Sub-Area B commonly known as 601-31 W. Adams and 201-41 S. DesPlaines Street, Chicago Illinois. This amendment to IPD 842 only pertains to the property located in Sub-Area B (“the Property”). The Property in Sub-Area B contains approximately 40,881 square feet of site area (0.938 acres). The property is owned by the Catholic Bishop of Chicago and controlled by the Applicant, 625 W. Adams (Chicago), LLC.
  
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the applicant’s successors and assigns and, if different than the applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined section 17-8-0400 of the Zoning Ordinance.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans, and subject to review and approval by the Department of Business Affairs and Consumer Protection.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Housing and Economic Development and Transportation.

The following uses shall be permitted within the area herein delineated as Sub-Area B of the Institutional Planned Development 842, as amended: retail, office, religious assembly, cafetorium, accessory and non-accessory parking, and related uses and services and all uses allowed in the DC Downtown Core Use District.
6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Housing and Economic Development. Off-Premise signs are prohibited within the boundary of the Planned Development.
7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations established by the Federal Aviation Administration.
8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 40,881 square feet.

Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Housing and Economic Development for Sub-Area B. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
10. The Site and Landscape plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Housing and Economic Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Environment and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.

The applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in Sub-Area B in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. At the time of a hearing before the Chicago Plan Commission, all developments must be in substantial compliance with the current City of Chicago Sustainable Development Policy set forth by the Housing and Economic Development. The Applicant shall construct the building located in Sub-Area B under the Leadership in Energy and Environmental Design (LEED) Green Building Rating System. The Applicant shall provide a vegetated (“green”) roof of at least fifty percent (50%) of the building’s net roof area by providing a green roof of 11,910 square feet. “Net roof area” is defined as total roof area minus any required perimeter setbacks, roof top structures, and roof-mounted equipment.



**EXISTING ZONING MAP**




PROPERTY LINE MAP**









**EAST ELEVATION**




