WHEREAS, From time to time, vehicles and equipment used by the City of Chicago become outdated and obsolete and are replaced; and

WHEREAS, Such materials may nonetheless have useful service left in them and could be of great use to another entity; and

WHEREAS, From time to time, the City's Department of Fleet Management has in its possession ambulances and fire trucks that, while no longer of use to the City, could be of substantial use elsewhere; and

WHEREAS, The municipality of Apaseo El Alto in the state of Guanajuato, Mexico, is in need of humanitarian aid; now, therefore,

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** The Commissioner of Fleet Management is hereby authorized to donate one obsolete ambulance and one obsolete fire truck no longer useful to the City of Chicago, as such ambulance and fire truck may become available, to the municipality of Apaseo El Alto in the state of Guanajuato, Mexico, free and clear of any liens or encumbrances. The City shall convey said vehicles in "as is" condition without any warranties either expressed or implied and expressly excludes any warranty of merchantability and fitness for a particular purpose.

**SECTION 2.** The Commissioner of Fleet Management is hereby authorized to enter into and execute such other documents as may be necessary and proper to implement this donation.

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage and publication.
