Whereas , On Wednesday, August 1, 2011, the quick thinking of 24th District Police Officer Elizabeth Read (Star #8730) saved the life of a senior citizen; and

WHEREAS, An elderly woman was enjoying her breakfast at the local coffee shop located at Howard and Western Avenues, when she began to choke on a piece of food that became lodged in her throat; and

WHEREAS, Officer Read, who, fortunately, was in the coffee shop at the same time, noticed the woman in distress and, after assessing the situation, immediately sprang into action, rushing over to aid the woman; and

WHEREAS, When she reached the woman, Officer Read observed that the woman could not breathe and was on the verge of unconsciousness; and

WHEREAS, Realizing that there was no time to lose, Officer Read, using her knowledge and training, positioned herself behind the woman and administered the Heimlich maneuver, successfully dislodging the obstruction and allowing the woman to begin breathing again; and

WHEREAS, When the woman, who suffered from asthma and other health issues, continued to experience distress and coughing, Officer Read stayed with the woman until she calmed down and her breathing returned to normal; and

WHEREAS, The rescue of this elderly woman would not have been possible if not for the outstanding lifesaving procedures performed by Officer Read; and

WHEREAS, Officer Read's quick thinking and cool head have earned her the respect and admiration of all Chicagoans; now, therefore,
