ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single Family District symbols and indications as shown on Map No. 3G in the area bounded by

West Chestnut Street; a distance 218 feet north of West Chestnut Street on North Noble Street; a distance 82 feet east of North Noble Street to the adjacent north-south public alley; a distance of 90 feet south to the east-west public alley that runs parallel to West Chestnut Street; a distance of 200 feet east of North Noble Street; a distance of 128 feet south to West Chestnut Street; a distance of 200 feet west along West Chestnut Street to North Noble Street.

to those of a RM-6 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about October 26, 2011, the undersigned will file an application for a change in zoning from a RS-3 designation to a RM-6 designation on behalf of St. Boniface Senior Living LLC for the property located at 1358 West Chestnut / 921 North Noble in Chicago, Illinois ("Property").

The Applicant intends to transform the former St. Boniface Campus into a residential development containing 84 units of housing for seniors 62 years and older. The project will redevelop the existing church in a manner that preserves the building's historic elevations and bell towers, as agreed to in the Redevelopment Agreement between the City of Chicago and the Applicant dated October 20, 2010 which governs this property. The project will also include development of an attractively designed three story masonry addition on the adjacent empty lot located immediately to the south. There will be 37 parking spaces and one loading dock provided on the property.

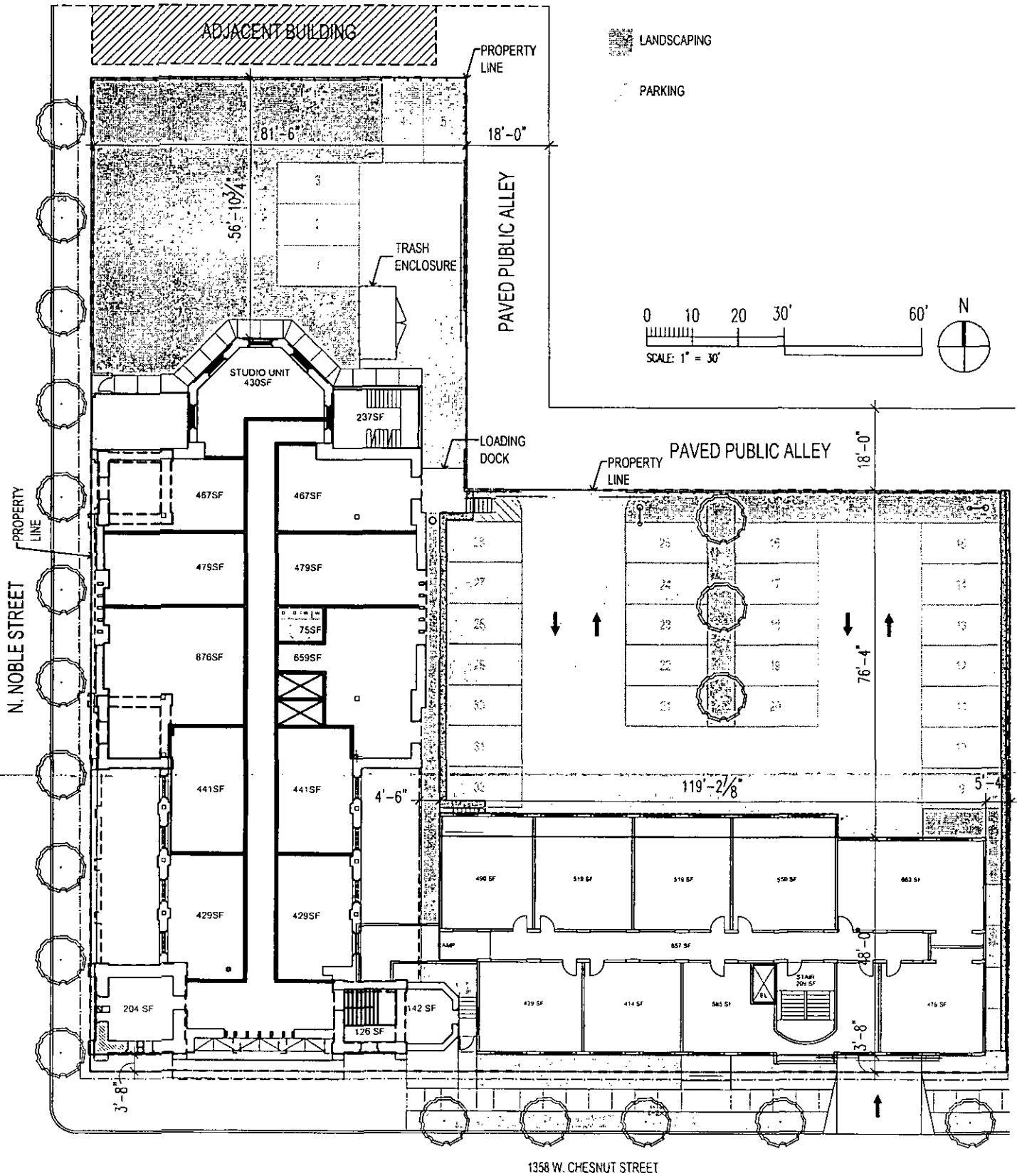


Site Plan Basement Level

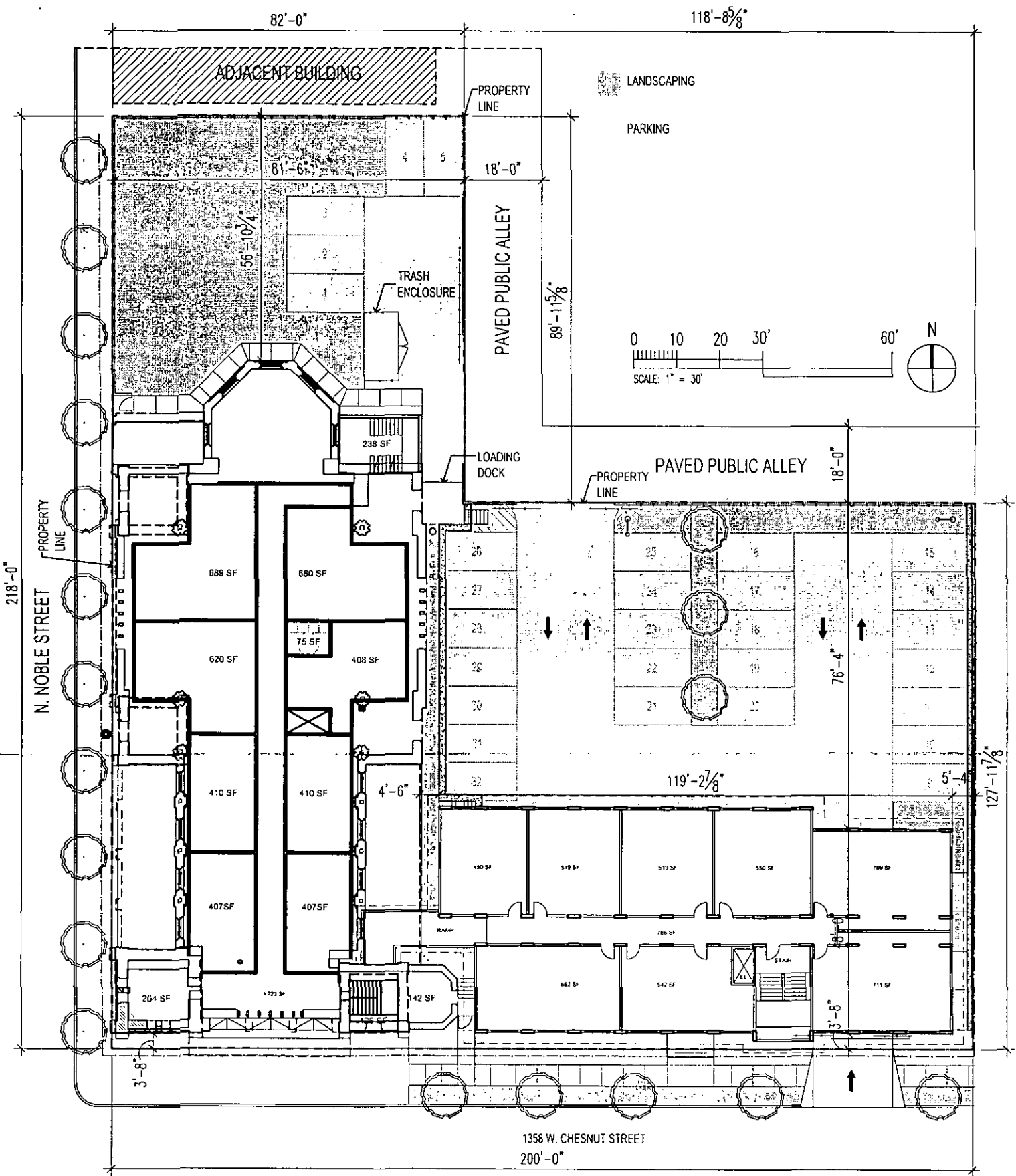

Site Plan Level 02

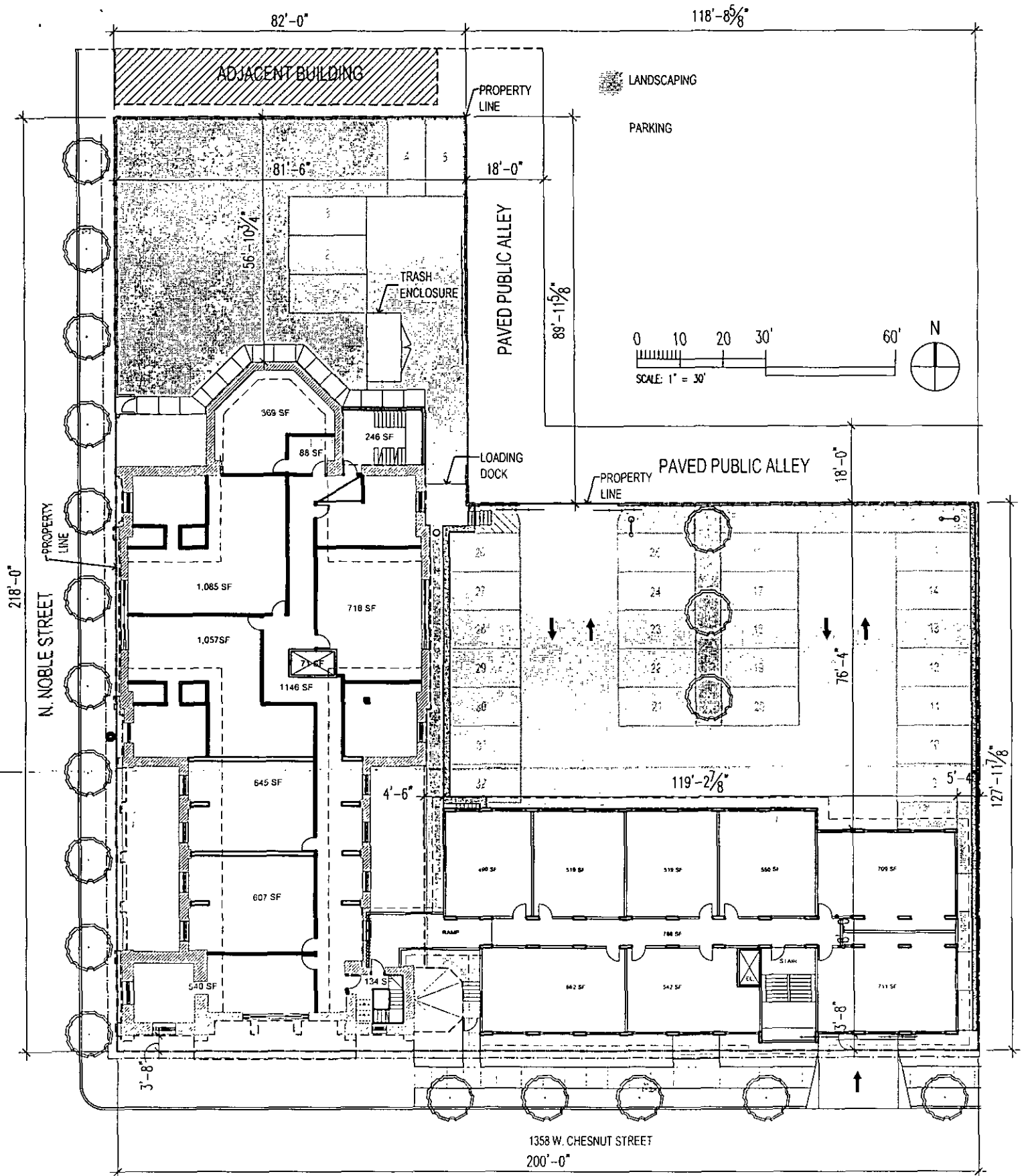


Site Plan Level 03



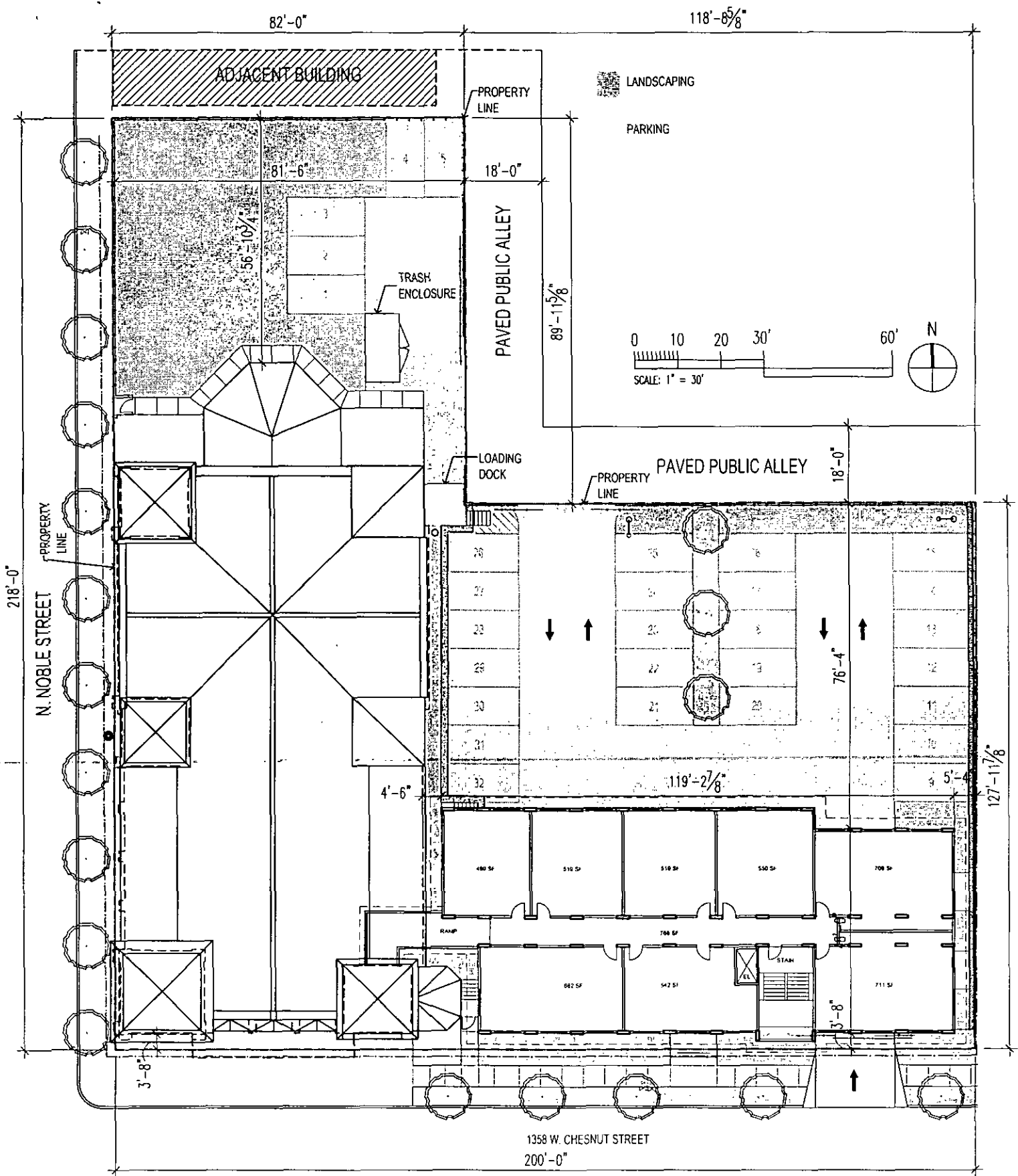
Site Plan Level 04

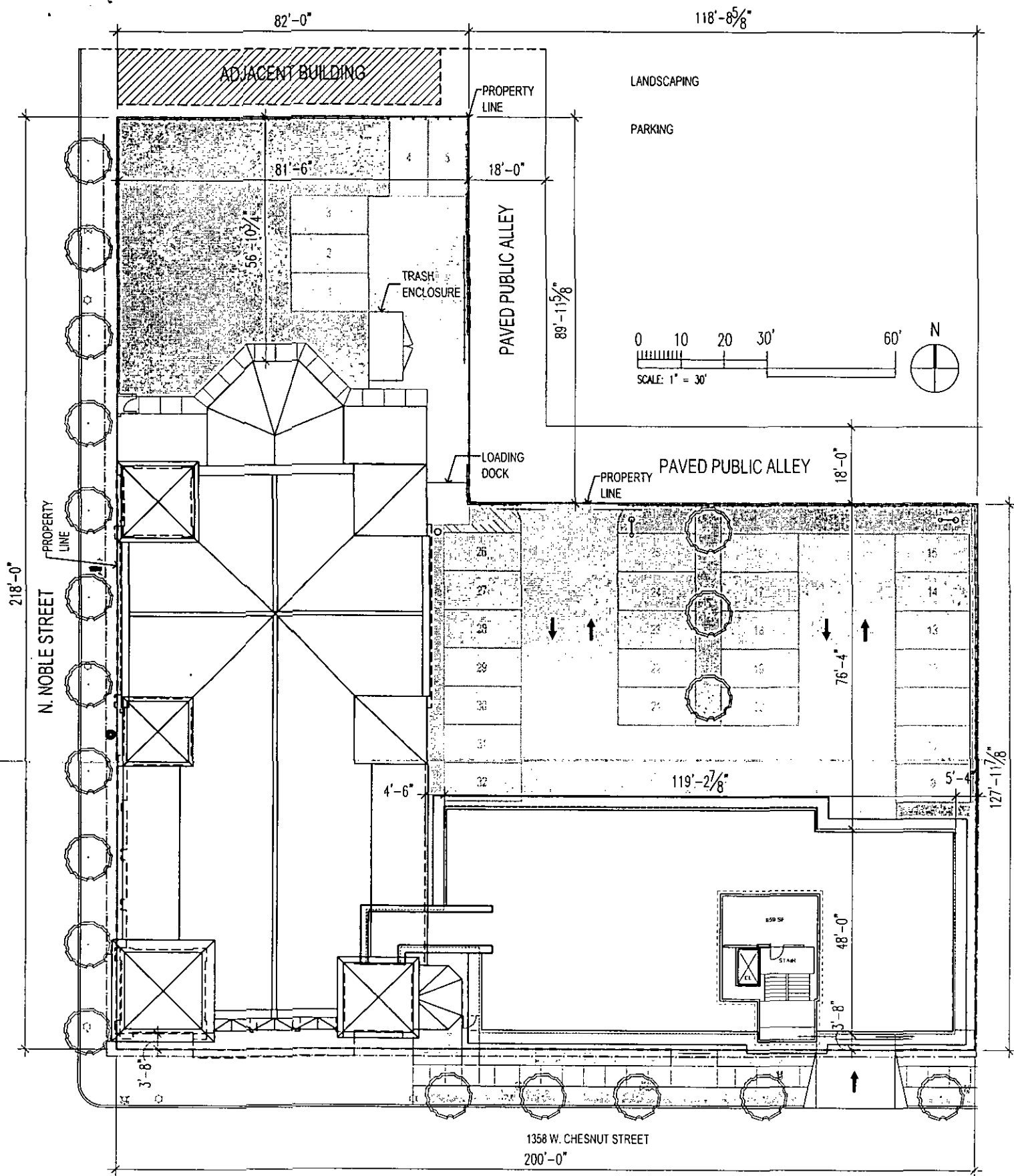
Site Plan Level 05

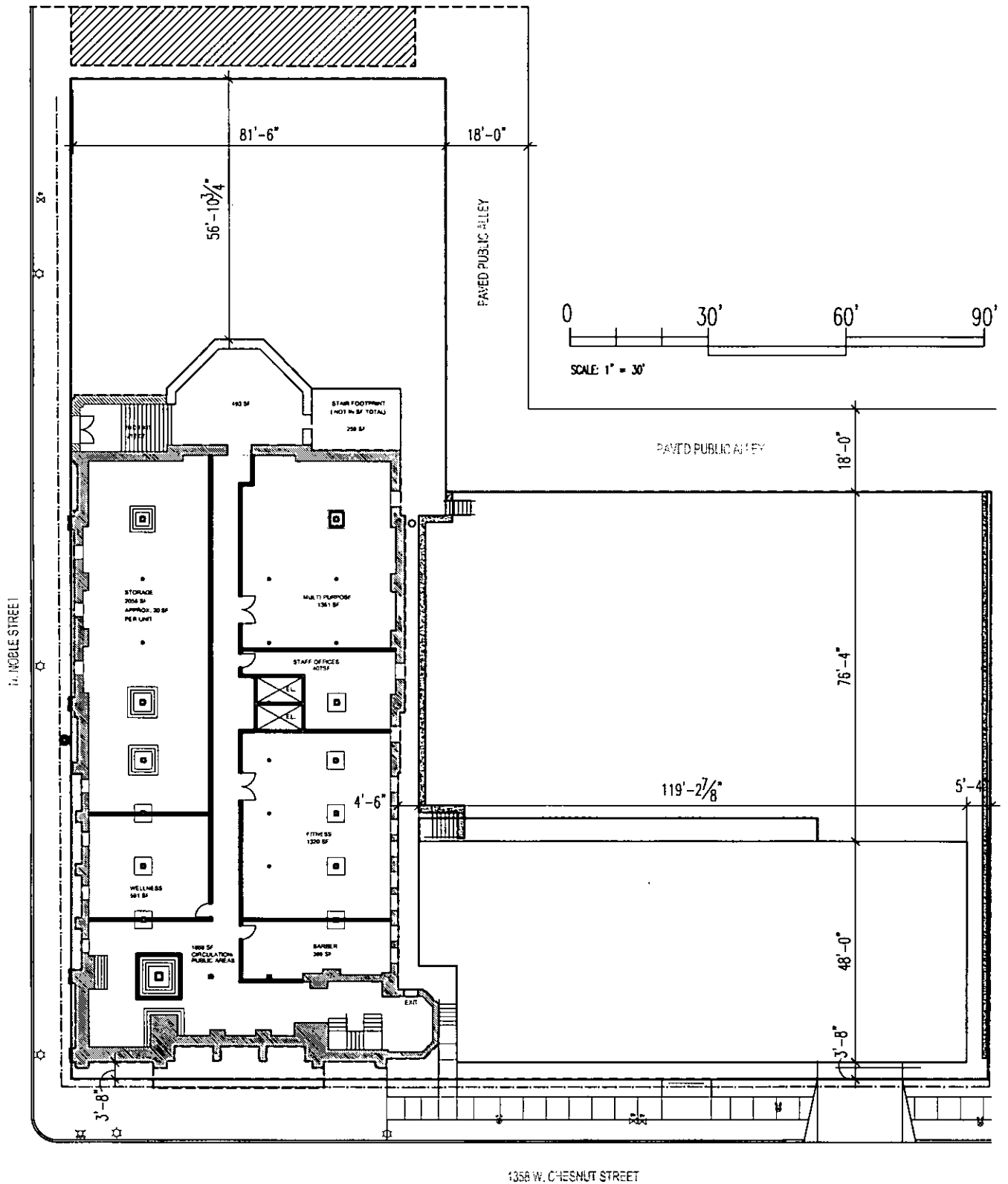
Site Plan Level 06

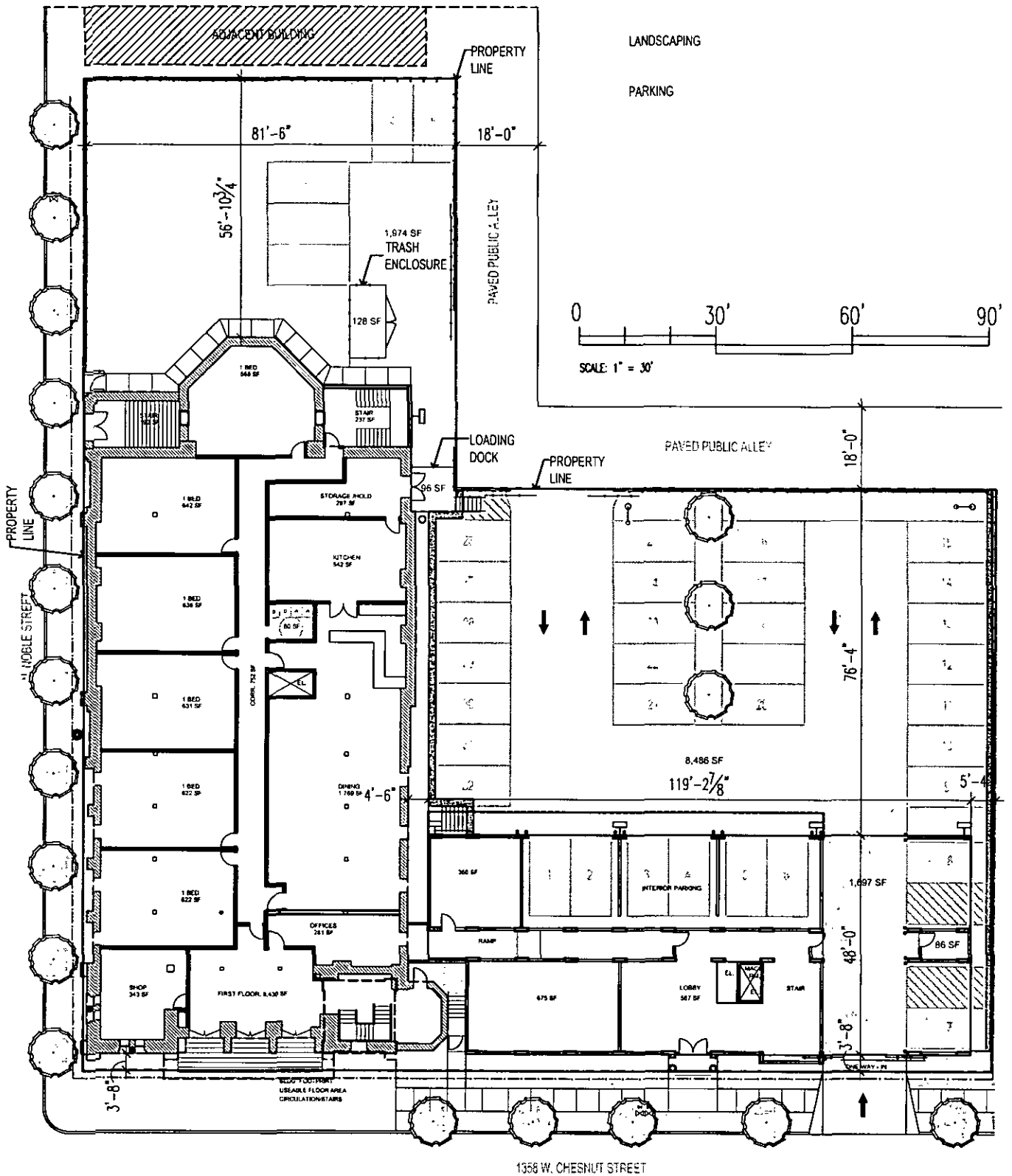


Site Plan - Roof Level

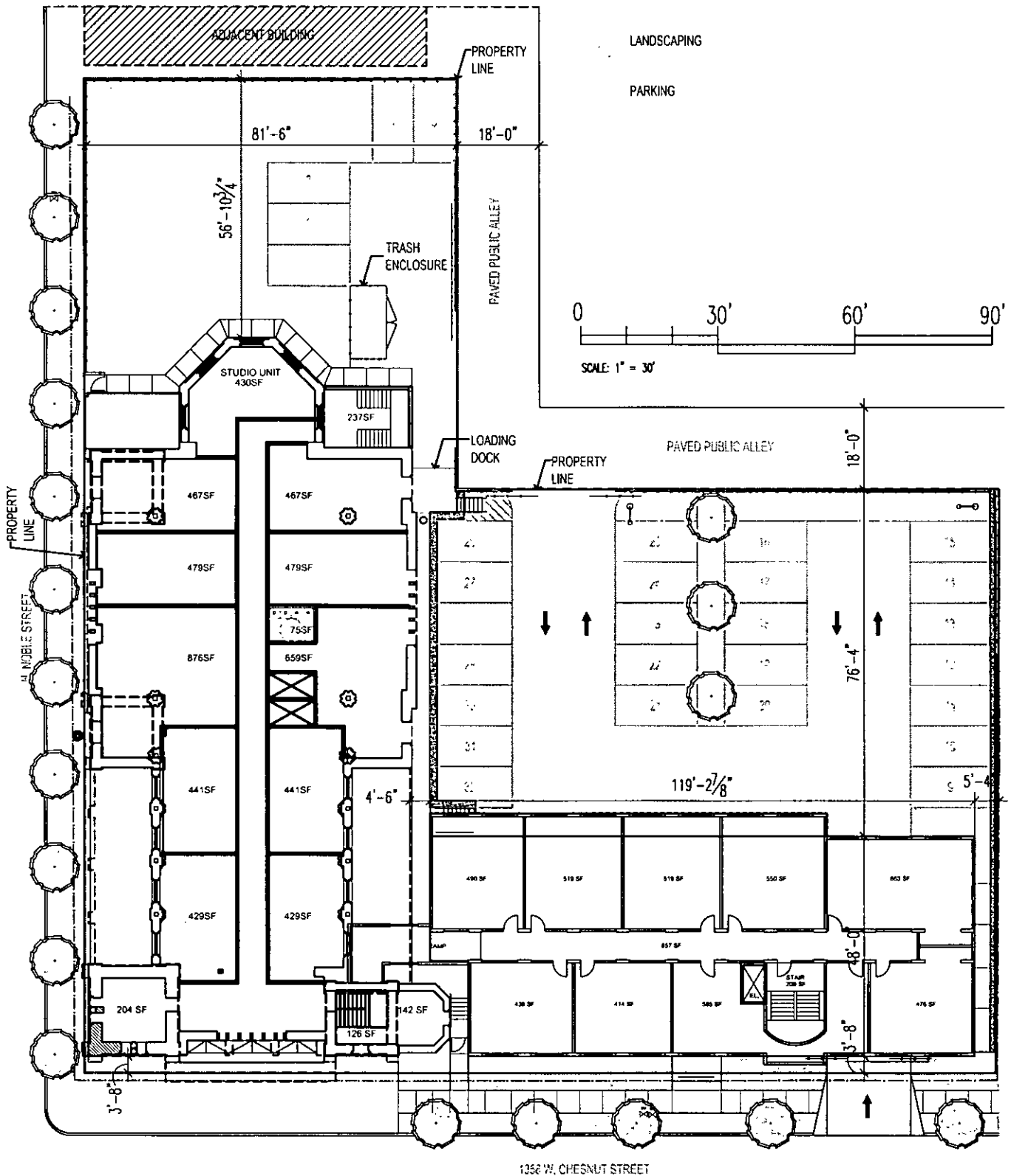


Site Plan Basement Level

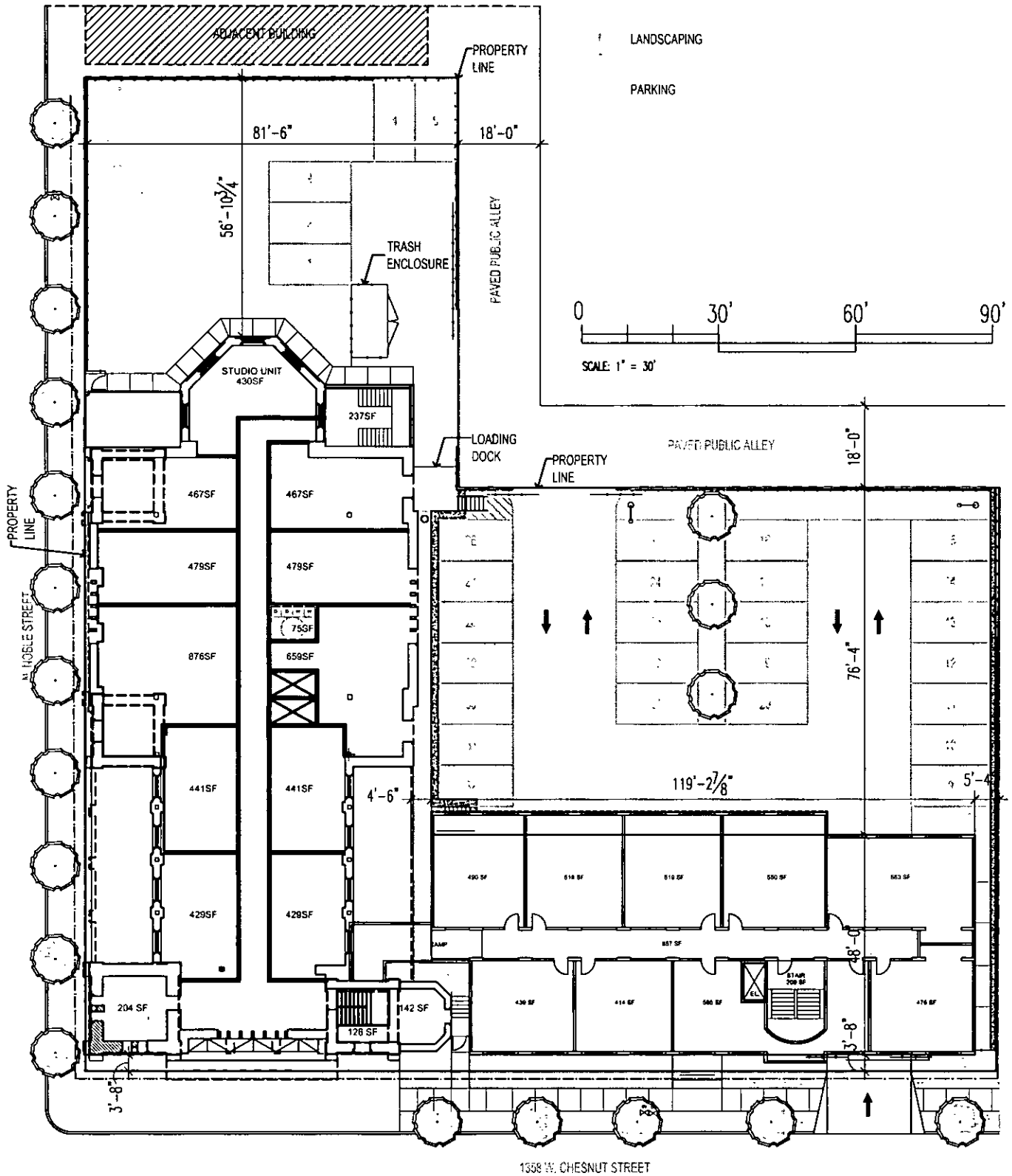


Site Plan Level 01

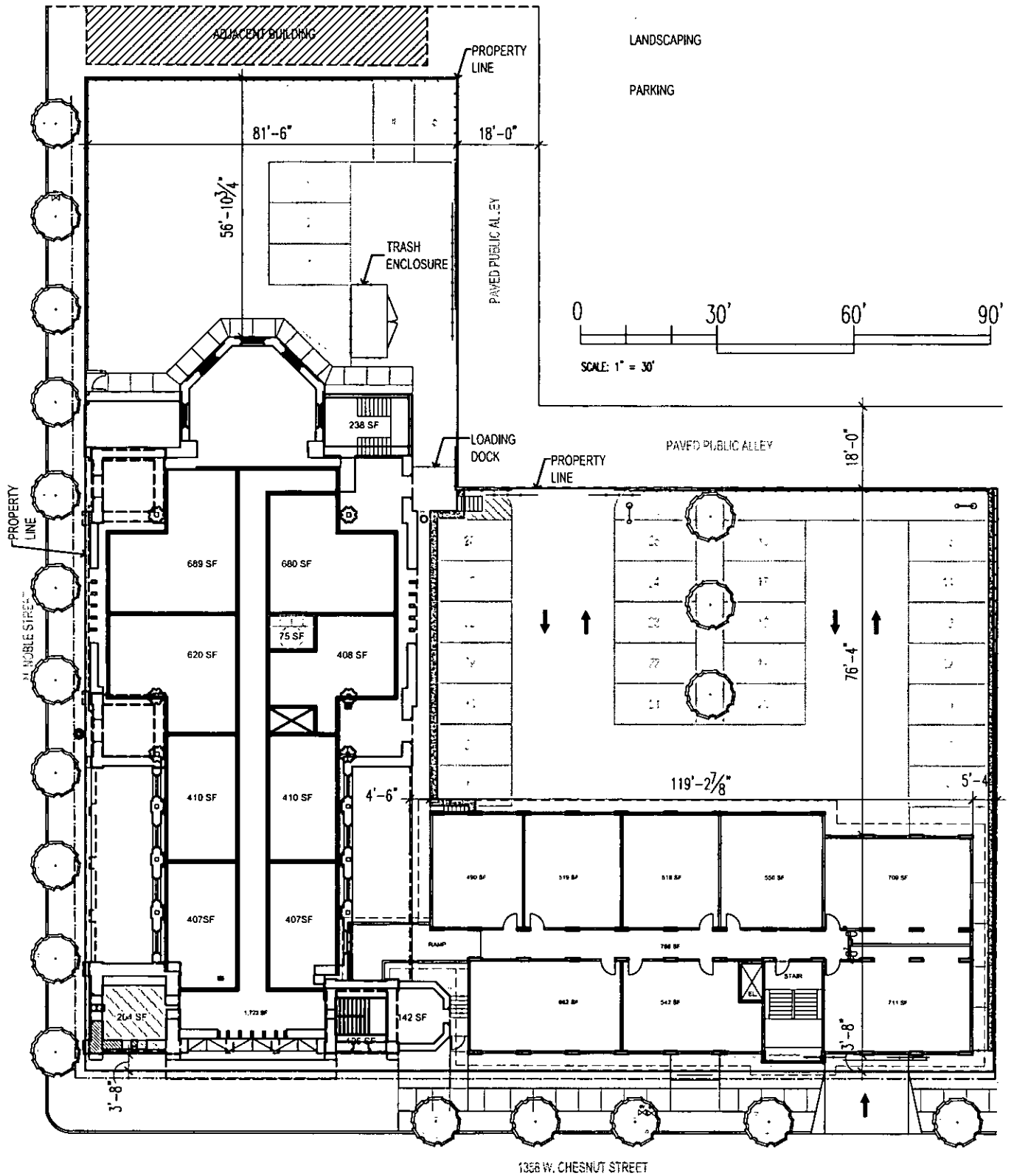


Site Plan Level 02

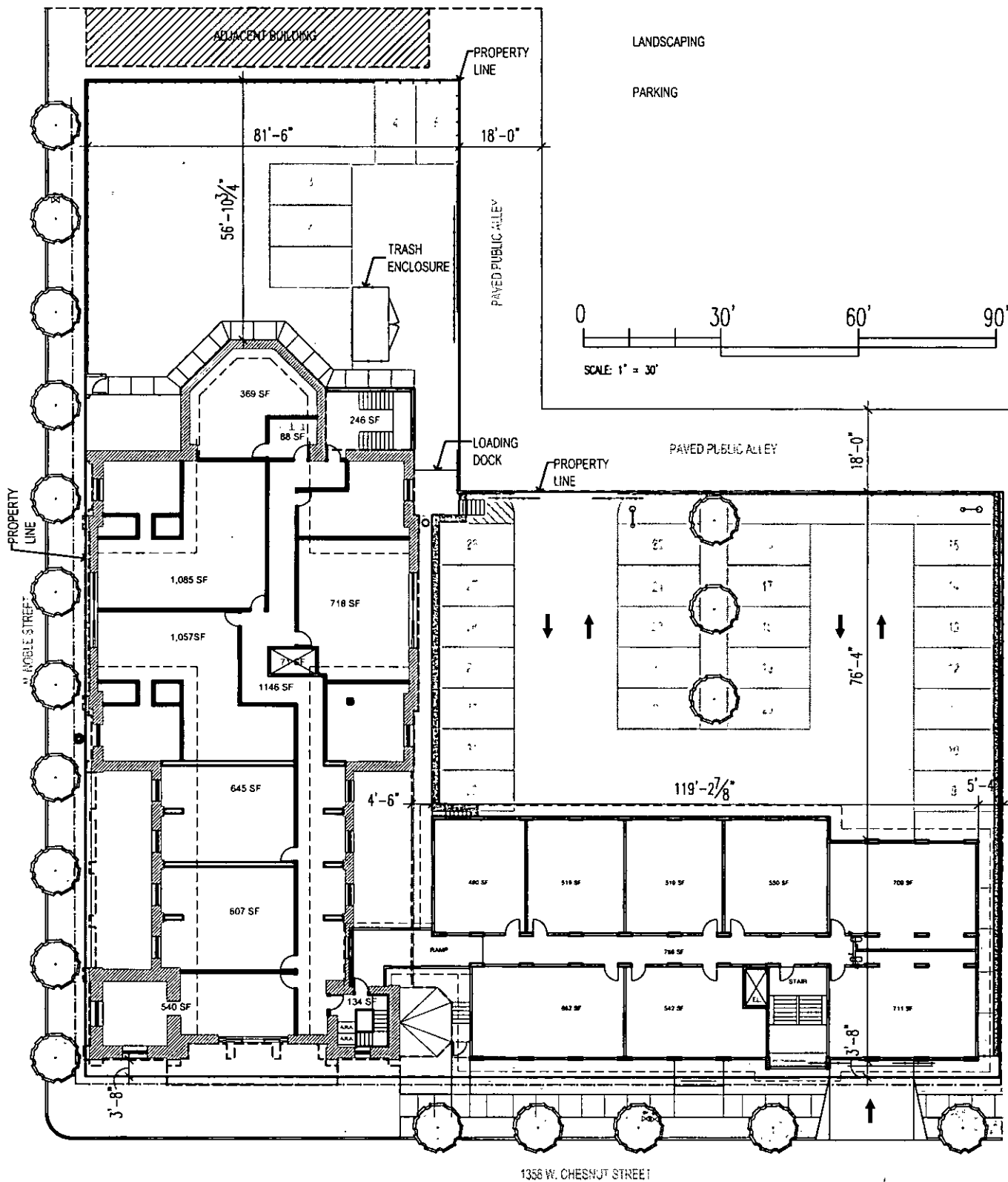

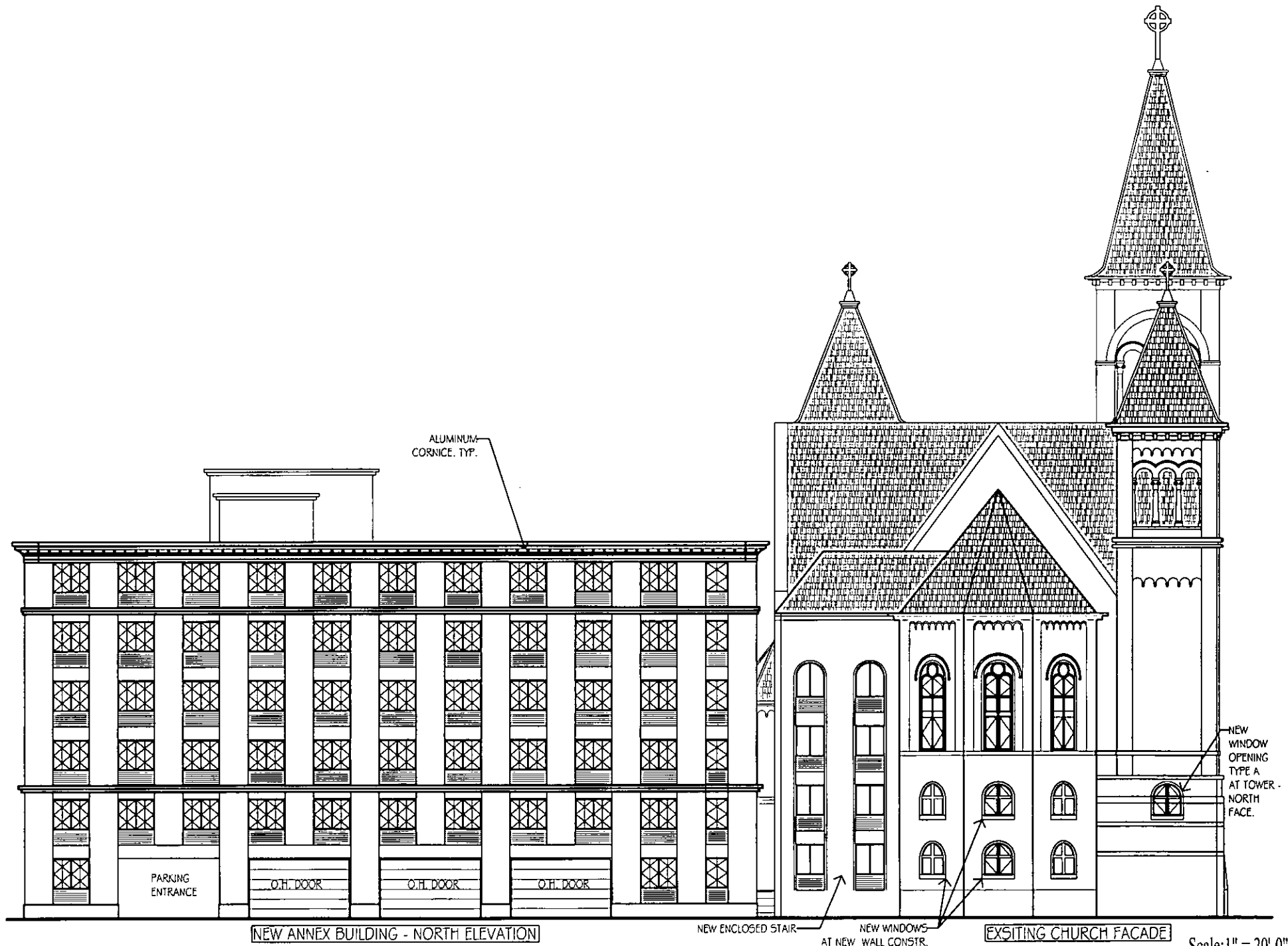


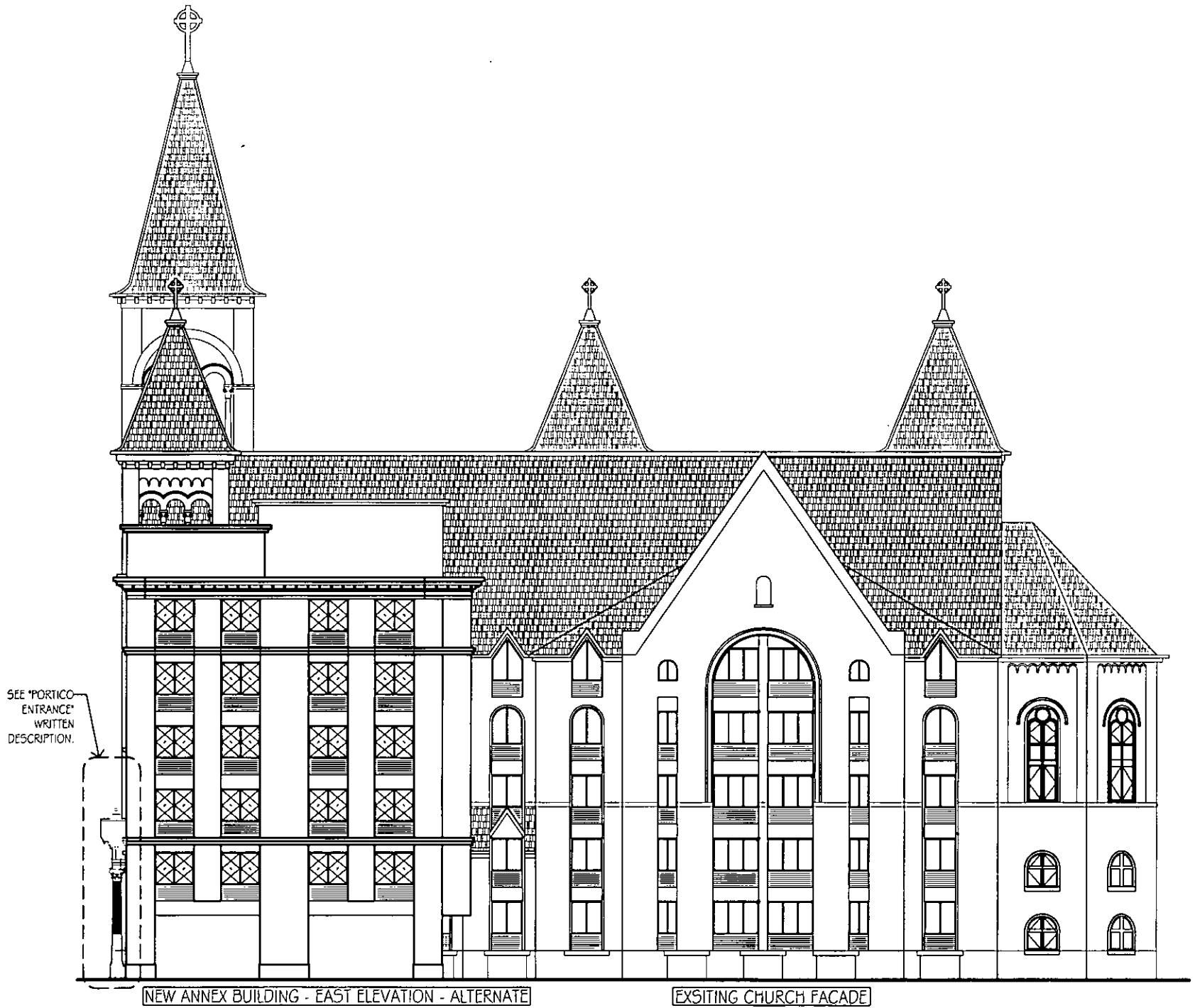
Site Plan - Roof Level

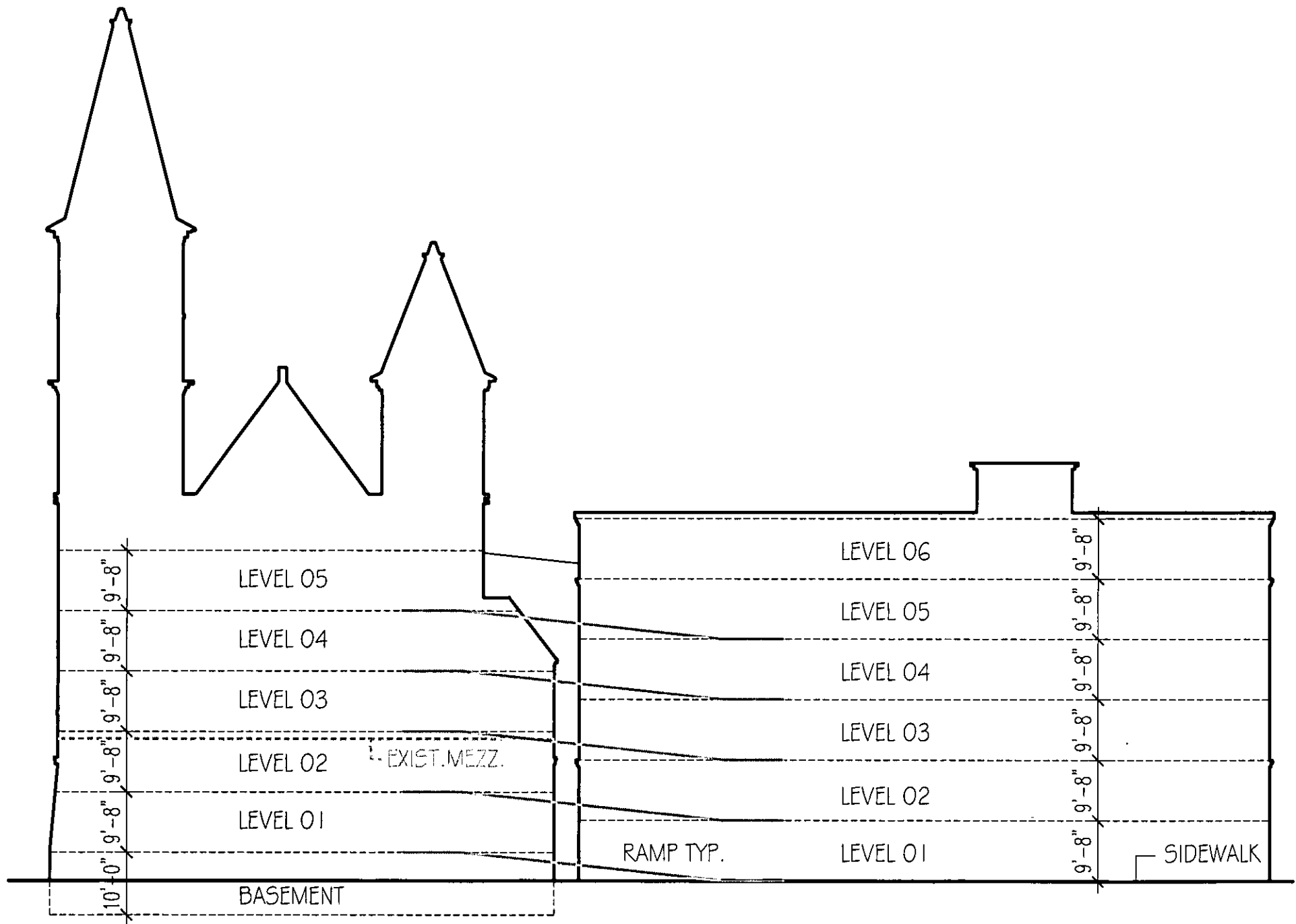
