RANDOLPH WINE CELLARS

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to RANDOLPH WINE CELLARS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, seven (7) Awning(s) projecting over the public right-of-way adjacent to its premises known as 1415 W. Randolph St..

Said Awning(s) at W. Randolph Street measure(s):

One (1) at ten point six (10.6) feet in length, and two (2) feet in width for a total of twenty-one point two (21.2) square feet.

One (1) at five (5) feet in length, and four (4) feet in width for a total of twenty (20) square feet.

One (1) at five (5) feet in length, and two (2) feet in width for a total of ten (10) square feet.

One (1) at eleven point six (11.6) feet in length, and two (2) feet in width for a total of twenty-three point two (23.2) square feet.

One (1) at four (4) feet in length, and four (4) feet in width for a total of sixteen (16) square feet.

One (1) at eleven point six (11.6) feet in length, and two (2) feet in width for a total of twenty-three point two (23.2) square feet.

One (1) at seven (7) feet in length, and four (4) feet in width for a total of twenty-eight (28) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1098373 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

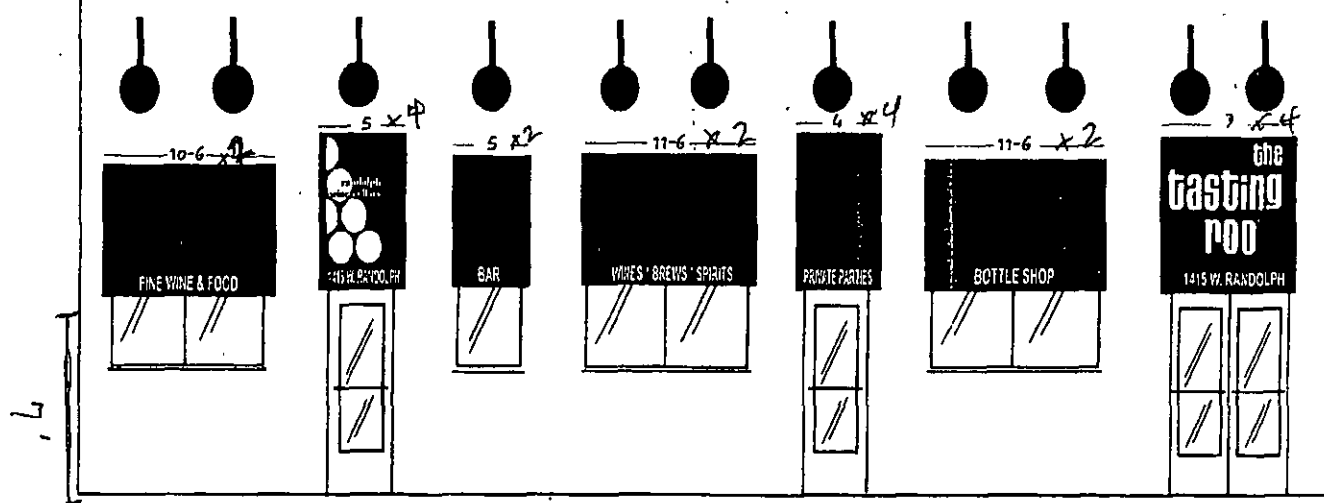
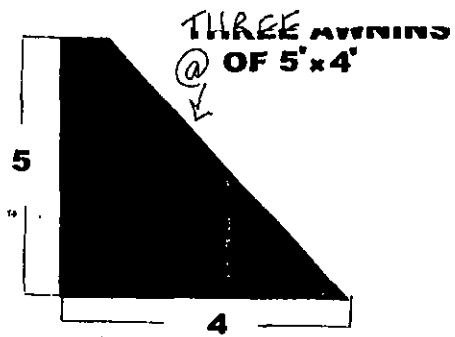
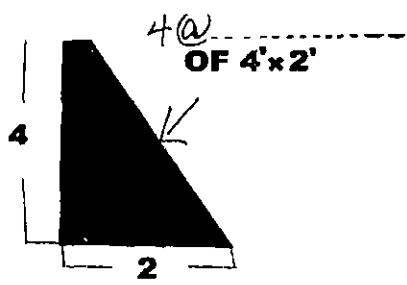
