## **ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

**SECTION 1.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance

be amended by changing all the PD 1041 symbols and indications as shown on Map No. 4-E in the area bounded by:

East 21<sup>st</sup> Street; South Indiana Avenue; a line approximately 180 feet north of and parallel to East 22<sup>nd</sup> Street; and the alley next west of and parallel to South Indiana Avenue,

to those of a DX-5, Downtown Mixed-Use District which is hereby established in the area described and a corresponding use district.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.
