In accordance with the requirements of Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on December 14, 2011, 2100 S. Indiana Avenue Equities, LLC (the "Applicant") will file an application for rezoning (the "Application"). The Applicant proposes to renovate and rehabilitate an existing 4-story building on the property commonly known as 2100-2124 South Indiana Avenue and 119-133 East 21st Street (the "Property").

The proposed rezoning application will request City of Chicago approval to rezone the Property from Residential Business Planned Development Number 1041 to DX-5, Downtown Mixed Use District for the purpose of renovating an existing, vacant, 4-story warehouse building with approximately 54 dwelling units, 61 parking spaces and approximately 13,000 square feet of commercial retail space (the "Project").




