## **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 4-F in the area bounded by:

W. 16<sup>th</sup> Street, S. Federal Street, W. 17<sup>th</sup> Street and S. Clark Street

to those of a DS-5 Downtown Service District.

SECTION 2. This ordinance takes effect after its passage and approval.

The City of Chicago, through the Department of Housing and Economic Development ("DHED"), is the owner of the real property comprising roughly  $\frac{3}{4}$  of the block bounded by W. 16<sup>th</sup> Street on the north, S. Dearborn Avenue on the east, W. 17<sup>th</sup> Street on the south and S. Clark Street on the west (the "Property"). 1625 South Clark Street, LLC (the "Company") proposes to acquire the Property from the DHED by negotiated sale and from CDOT by vacation of streets and alley and to construct on the Property and vacated public ways an approximately 64,000 square foot grocery store to be leased and operated as a Mariano's Fresh Market.

A portion of the Property is currently zoned B1-1 Neighborhood Shopping District and a portion of the Property is zoned DS-5 Downtown Service District. It is the recommendation of the Bureau of Zoning of DHED that the portion of the Property that is zoned B1-1 be rezoned to DS-5 so that the entire Property is within the DS-5 Downtown Service District. DHED hereby authorizes the Company to apply for an amendment to the Chicago Zoning Ordinance to change all of the B1-1 Neighborhood Shopping District symbols and indications for the Property to DS-5 Downtown Service District.

SUPPLEMENTAL SUBMISSION FOR TYPE 1 REZONING

**PROJECT DESCRIPTION:**

1625 South Clark Street, LLC, a Delaware limited liability company (the “Applicant”) is applying for a “Type 1” rezoning of the land (the “Subject Property”) bounded by W. 16<sup>th</sup> Street on the north, S. Federal Street on the east, W. 17<sup>th</sup> Street on the south and S. Clark Street on the west, in, Chicago, Illinois. The Applicant proposes to rezone the Subject Property from a B1-1 Neighborhood Shopping District to a DS-5 Downtown Service District.

The Applicant proposes to acquire the Subject Property and an adjacent parcel situated east of S. Federal Street (the “Additional Parcel,” and together with the Subject Property, the “City Owned Parcel”) from the City of Chicago and to construct on the City-Owned Parcel an approximately 65,000 square foot full service grocery store at ground level, with two levels of parking located above the ground floor grocery store (the “Project”). The grocery store and parking will be constructed on the southerly half of the City-Owned Parcel. There will also be a small surface parking lot constructed on the portion of the City-Owned Parcel situated to the north of the grocery store building. The Project will be served by approximately 340 total accessory off-site parking spaces. The grocery store will be a full service grocery store and is expected to have approximately 400 full and part-time employees.

It is anticipated that the portion of S. Federal Street between W. 16<sup>th</sup> Street and W. 17<sup>th</sup> Street will be vacated. Primary access to the grocery store will be from W. 16<sup>th</sup> Street.

The City, through its Department of Housing and Economic Development, has authorized the Applicant to apply to rezone the Subject Property to accommodate the Project and to conform the zoning of the Subject Property and the Additional Parcel to a uniform DS-5 zoning classification.

The Project’s building height will be approximately 40 feet. There is no maximum building height limit in a DS-5 District.

The aggregate net site area of the Subject Property, the Additional Parcel and the to be vacated portion of S. Federal Street is approximately 105,209 square feet square feet and the projected area of the grocery store building comprising the Project is 65,000 square feet. As such, the Project requires a floor area ratio of 0.62. The maximum floor area ratio in a DS-5 Downtown Service District is 5.0.

Building setbacks for the Project will be in conformity with the attached site plan and will comply with the requirements of the DS-5 Downtown Service District. Landscaping will be provided in accordance with the Chicago Landscape Ordinance.

Included herewith are a preliminary site plan, building elevations and a landscape plan for the Project.
