ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-1 Neighborhood Commercial District symbols and indications as shown on Map No. 5-J in the area bounded by

West Armitage Avenue; a line 99 feet west of and parallel to North Kedzie Avenue; the public alley next south of and parallel to West Armitage Avenue; A line 124 feet west of and parallel to North Kedzie Avenue,

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.



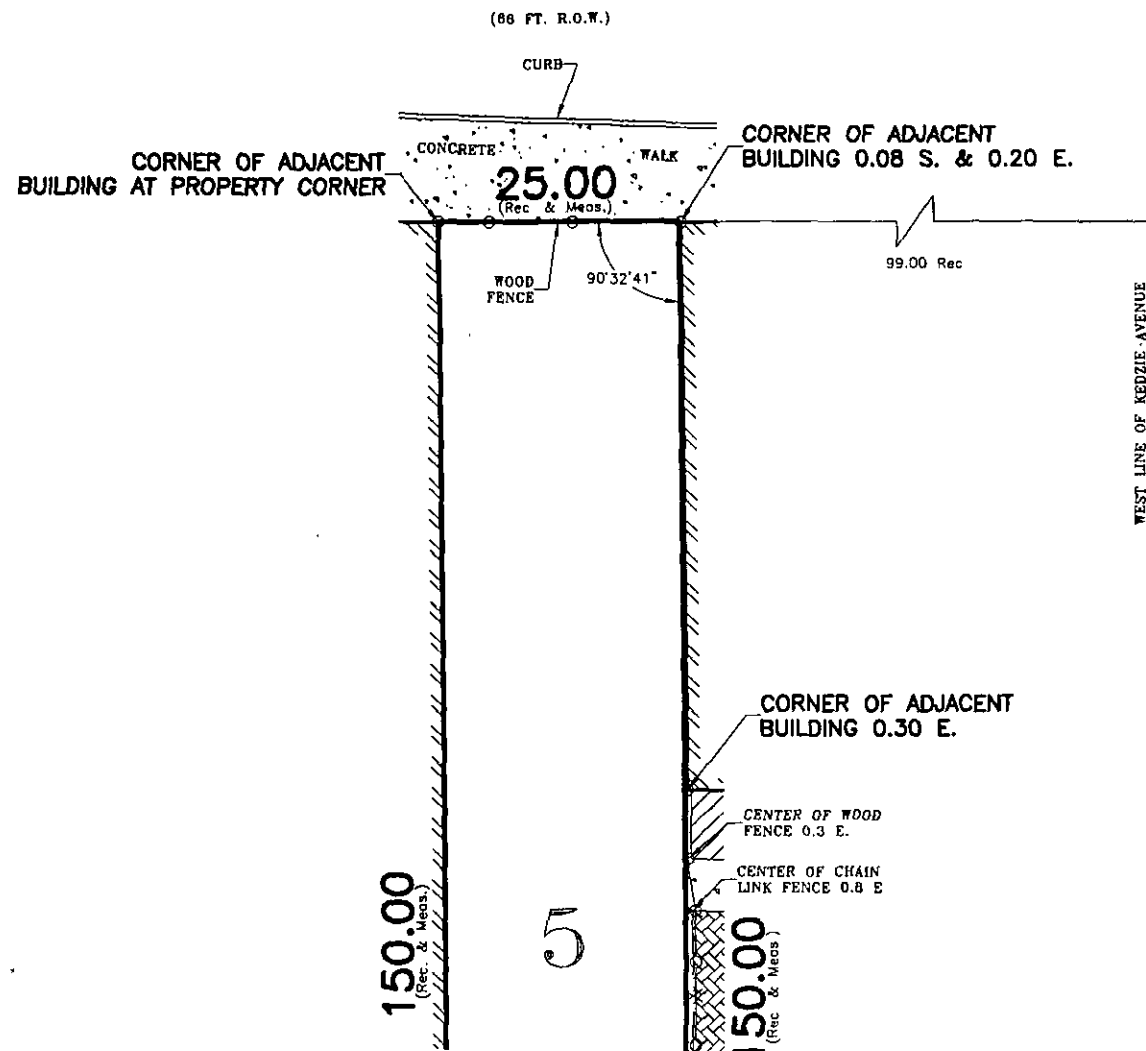

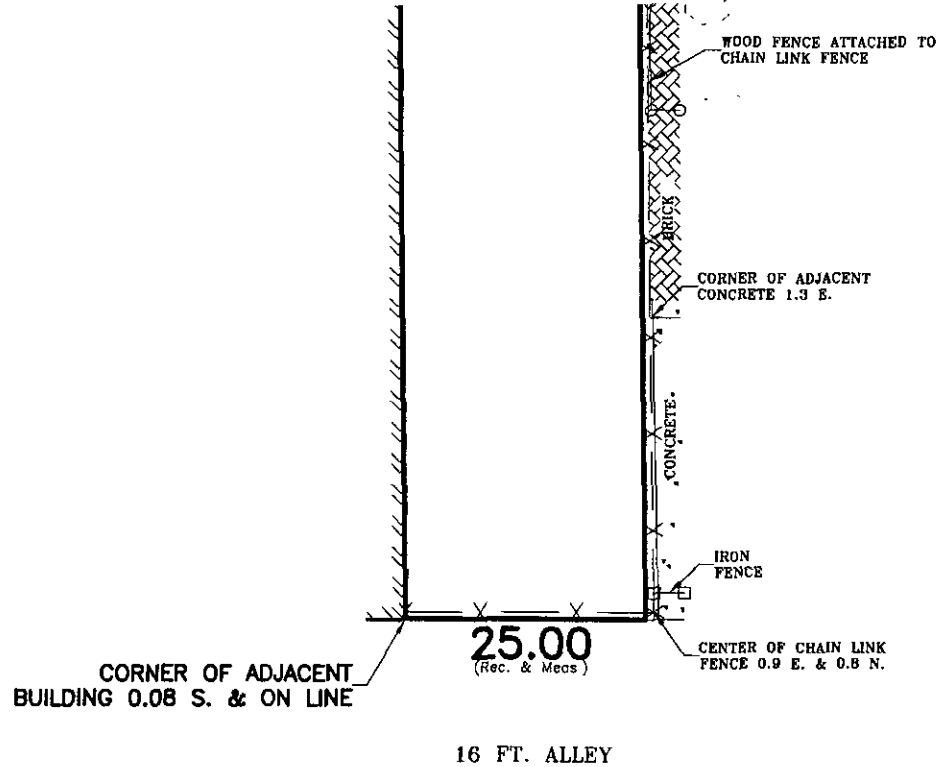
