S U B S T I T U T E ORDINANCE AMERITECH Acct No. 207268 - 47 Permit No. 1098247

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to AMERITECH, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, twenty-two (22) four (4) inch plastic ducts in the City's existing Chicago Avenue water pipe tunnel under the north branch of the Chicago River adjacent to 800 North Throop Street and in the east and west access shafts and whereas for the privilege granted herein the Ameritech shall pay to the City of Chicago an annual compensation of fifty cents (\$ 50) per lineal foot of tunnel per duct multiplied by three hundred three (303) feet of tunnel.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1098247 herein granted the sum of three thousand three hundred thirty-three (\$3,333.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 03/25/2010.
