#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 8-I in the area bounded by

South Albany Avenue; a line 589.34 feet long beginning at a point 228.19 feet north of West 37<sup>th</sup> Place on the eastern boundary of South Albany Avenue; to the intersecting point of a line 90.93 feet north of and parallel to West 37<sup>th</sup> Place and a line 574.18 feet west of and parallel to South Albany Avenue; a line 90.93 feet north of and parallel to West 37<sup>th</sup> Place, a line 600 feet east of and parallel to South Albany Avenue; and West 37<sup>th</sup> Place,

to those of a M2-3 Light Industry District.

SECTION 2. This ordinance takes effect after its passage and approval.




