## ORDINANCE -

- WHEREAS, the City of Chicago (the "City") is a home rule unit of government by virtue of the provisions of Article VII, Section 6(e) of the Constitution of the State of Illinois of 1970, and, as such, may exercise any power and perform any function pertaining to its government and affairs; and
- WHEREAS, the City Council of the City (the "City Council") finds that there is a lack of sufficient open space in the City for recreational and aesthetic uses, and as a result there is a need to develop small open spaces as parks, gardens and natural areas for public use for the benefit of the citizens of the City; and
- WHEREAS, the Chicago Plan Commission ("<u>CPC</u>"), the Chicago Park District and the City Council have previously prepared and approved that certain planning document entitled, "City Space: An Open Space Plan For Chicago," dated January 1998 (the "<u>Open Space Plan</u>"), which sets forth certain goals and objectives for increasing open space in the City; and
- WHEREAS, the City owns the real property commonly known as 1415 North Washtenaw Avenue, Chicago, Illinois, and identified on Exhibit A attached hereto and made a part hereof (the "City Property"); and
- WHEREAS, Erie Elementary Charter School, an Illinois not-for-profit corporation (the "School"), owns certain real property adjacent to the City Property, commonly known as 1405 North Washtenaw Avenue, 2650 West Hirsch Street and 2730 West Hirsch Street, Chicago, Illinois, and identified on Exhibit B attached hereto and made a part hereof (the "Adjacent Property"); and
- **WHEREAS**, the Adjacent Property is improved with a school, commonly known as the Erie Elementary Charter School; and
- WHEREAS, the City Property has an appraised fair market value of Fifty-Five Thousand Dollars (\$55,000); and
- WHEREAS, by Resolution No. 11-094-021, adopted by the CPC on December 15, 2011, the CPC recommended the sale of the City Property to the School; and
- WHEREAS, public notices advertising the Department of Housing and Economic Development's intent to convey the City Property to the School appeared in the Chicago Sun-Times on December 25, 2011, and January 1 and 8, 2012; and
- WHEREAS, no alternative proposals were received by the deadline indicated in the aforesaid notices; and
- WHEREAS, the City desires to convey the City Property to the School for use as an outdoor playground for the students of Erie Elementary Charter School; and

- WHEREAS, the City Council finds that the establishment of additional public open space is essential to the general health, safety and welfare of the City; and
- WHEREAS, the City Council finds that such conveyance is consistent with the goals and objectives of the Open Space Plan; and
- WHEREAS, the City Council finds that the conveyance of the City Property to the School is in the best interests of the City; now therefore,

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

- **SECTION 1.** The foregoing recitals, findings and statements of fact are hereby adopted as the findings of the City Council.
- <u>SECTION 2</u>. The City hereby approves the conveyance of the City Property to the School for the sum of One and No/100 Dollar (\$1.00).
- SECTION 3. The Mayor or his proxy is authorized to execute, and the City Clerk is authorized to attest, a quitclaim deed (or quitclaim deeds) conveying the City Property to the School. The quitclaim deed shall include the following covenant running with the land, or language substantially similar and acceptable to the Corporation Counsel:

Erie Elementary Charter School (the "School") shall construct on the City Property a playground substantially in accordance with the plans attached as Exhibit C to the ordinance authorizing this conveyance or such revised plans as may be approved in writing by the Commissioner of the City's Department of Housing and Economic Development or his designee. The construction of such playground shall be completed within twelve (12) months of the date of this deed. The School shall allow the City Property to be used only for an outdoor playground. The City, acting through the Commissioner of Housing and Economic Development, shall have authority to release this covenant upon the request of the School. If the School (i) does not construct the playground in accordance with this covenant or (ii) allows the City Property to be used for any purpose other than a playground without first obtaining a release of this covenant, the City may re-enter and take possession of the City Property, terminate the estate conveyed to the School, and revest title to the City Property in the City.

- <u>SECTION 4.</u> If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.
- <u>SECTION 5.</u> All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 6. This ordinance shall be in full force and effect immediately upon its passage and approval.




