Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY COMMONS III CONDO ASSN., upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Landscaping(s) on the public right-of-way for beautification purposes adjacent to its premises known as 1001-1071 W. 15th St..

Said Landscaping(s) at 1001-1071 W. 15TH ST. measure(s):

One (1) at eight hundred seventy-two point five (872.5) feet in length, and thirty-five (35) feet in width for a total of thirty thousand five hundred thirty-seven point five (30537.5) square feet.

Said Landscaping(s) at 1001-1071 W. 15TH ST. measure(s):

One (1) at ninety-six (96) feet in length, and twenty (20) feet in width for a total of one thousand nine hundred twenty (1920) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).


This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1075608 herein granted the sum of zero (\$0.00) per annum in advance.

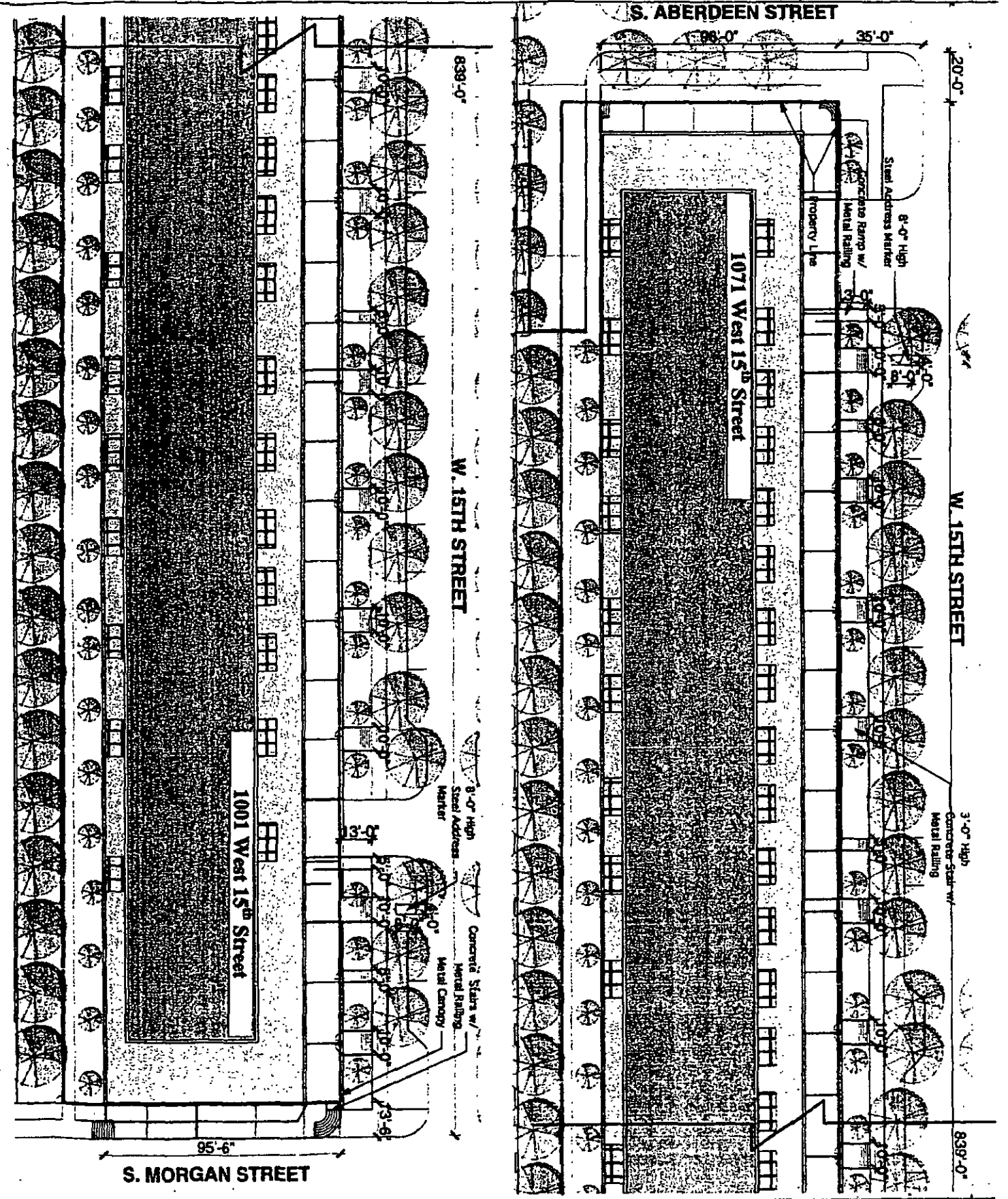
A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
