

ORDINANCE WALGREENS #15196 Acct. No. 147 - 122 Permit No. 1098664



SECTION 1. Permission and authority are hereby given and granted to WALGREENS #15196, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use six (6) Banner(s) projecting over the public right-of-way adjacent to its premises known as 151 N. State St...

Said Banner(s) at N. State measure(s):

Four (4) at point two five (.25) feet in length, and forty-three (43) feet in width for a total of forty-three (43) square feet.

Said Banner(s) at E. Randolph measure(s):

Two (2) at point two five (.25) feet in length, and forty-three (43) feet in width for a total of twenty-one point five (21.5) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1098664 hérein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
