Grant(s) of privilege in public way for University Commons VI Condo Assn. - area wells Committee on Transportation and Public Way Ľ.

ORDINANCE UNIVERSITY COMMONS VI CONDO ASSN Acct. No. 268378 - 10 Permit No. 1098495

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY COMMONS VI CONDO ASSN, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, ten (10) Area Well(s) with metal grating in the public right-of-way adjacent to its premises known as **1111-51 W. 14th Pl.**. Said area wells shall be described as follows:

Along West 14th Place shall be four (4) area wells. Each concrete area well with metal grating shall measure five (5) feet in length and six (6) feet, four (4) inches in width.

Along west 14th Place shall be six (6) area wells. Each concrete area well with metal grating shall measure five (5) feet in length and ten (10) feet, four (4) inches in width.

Concrete area wells with metal grating shall be used for the purposes of intake of fresh air and garage exhaust for basement.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1098495 herein granted the sum of four hundred (\$400.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 11/01/2011.
