ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS-2 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.9-I in the area bounded by

West Bryon Street; a line 159 feet west of and parallel to North Western Avenue; the alley next south of and parallel to West Byron Street; and a line 225 feet west of and parallel to North Western Avenue,

to those of a RS-3 Residential Single-Unit (Detached House) District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


After the re-zoning, the lots will be divided as follows: Lot 12 = 124.75'x 36' or 4491 sq. ft. and Lot 13 = 124.75'x 30' or 3724.50 sq. ft. The existing single family home with two car garage will remain on Lot 12. The other lot #13 will have an existing two story single family residence with one indoor parking spot. The existing two story single family residence on Lot 13 will have no changes made. There will be no commercial space. The building height of the two story rear coach house is approximately 13.1 ft.
