BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.12-J in the area bounded by

the alley next north of and parallel to West 55th Street; South Hamlin Avenue; West 55th Street; and a line 49.30 feet west of and parallel to South Hamlin Avenue,

to those of a B3-1 Community Shopping District and a corresponding use district is

hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
