***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-1 Limited Manufacturing/Business Park

District symbols and indications as shown on Map No.13-S in the area bounded by

beginning at a line 260.90 feet north of and parallel to West Foster Avenue (City Limits); a line 291.57 feet east of and parallel to North Sanford Avenue (City Limits) if extended; a line from a point 291.57 feet east of North Sanford Avenue if extended and 166.68 feet north of West Foster Avenue; to a point, 200.13 feet east of North Sanford Avenue if extended and 200.20 feet north of West Foster Avenue; and a line 200.13 feet east of and parallel to North Sanford Avenue (City Limits) if extended (ToB),

to those of a C2-1 Motor Vehicle-Related Commercial District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.
