Section 1. That an ordinance heretofore passed the City Council to install a loading zone on portions of designated street, be and the same is hereby amended by striking the following:

30 minute loading zone located adjacent to 61 East Superior Street (south curb)—unattended vehicles must have lights flashing—tow-away zone after 30 minutes—tow-away zone and inserting in lieu thereof

Loading Zone- tow-away zone

Section 2. This ordinance shall take effect and be in force hereinafter its passage and publication.
