## Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CHURCHILL ROW LOFTS CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, twelve (12) Balcony(s) projecting over the public right-of-way adjacent to its premises known as 2111 W. Said Balcony(s) at CHURCHILL measure(s): Twelve (12) at twelve (12) feet in length, and five (5) feet in width for a total of seven hundred twenty (720) square

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development). This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required

The grantee shall pay to the City of Chicago as compensation for the privilege #1098470 herein granted the sum of

A 25% penalty will be added for payments received after due date.


