

Pursuant to the provisions of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago, the Department of Housing and Economic Development hereby submits this report and recommendation on an amendment to Residential Planned Development No. 239 for your review and recommendation to the Chicago City Council. The application for the Chicago Zoning Ordinance was introduced into the City Council on November 2, 2011. Proper legal notice of the public hearing on the application was published in the Chicago Sun Times on, February 1, 2012. The Applicant was separately notified of this hearing.

The site is currently zoned Residential Planned Development No. 239. The applicant proposes to rezone the property from Residential Planned Development No. 239, to Residential Planned Development No. 239, as amended.

This development is being submitted by the Applicant, as a Planned Development pursuant to Section 17-13-0611-B, which states that a Planned Development review and approval is required when the proposed amendment is deemed a change of character to the overall development.

**PROJECT BACKGROUND**

Residential Planned Development No. 239 was approved by City Council on September 18, 1980 with a maximum number of 36 dwelling units, maximum F.A.R of 0.75 and a minimum of 36 required off-street parking spaces. The planned development was approved to allow the construction of five (2) story residential town homes and allow for recreational areas.

## **SITE AND AREA DESCRIPTION**

The Chicago Housing Authority currently owns the site and is in support of the planned development amendment. The site is located in the South Shore Community Area and is within the 71<sup>st</sup> and Stony Island Tax Increment Finance district. The site is not located in an Industrial Corridor or in a Landmark District. The total net site area of the site is 62,152 square feet and is rectangular. The area surrounding the site is comprised of residential, commercial and institutional buildings. The site is bordered on the east by a commercial area located immediately along Stony Island Avenue between East 71st Street and East 69th Street. Directly south is Chestnut Public Park and Fermi Public School with the remainder of the site surrounded by residential buildings.

The site is immediately accessible via public transit from CTA's No. 71<sup>st</sup>/ South Shore bus line, No. 28 Stone Island and the No. X28 Stony Island bus lines. The site is also served by the Stony Island METRA station located approximately one-half mile from the site.

## **PROJECT DESCRIPTION**

The applicant proposes the redevelopment and rehabilitation of five existing buildings on the subject property, to reduce the maximum dwelling unit count from 36 dwelling units to 32 dwelling units, add a use of community center / art gallery as an accessory use, and reduce the minimum required accessory parking spaces from 36 to 32. The applicant seeks to modify the center building and adopt new elevations.

Programming in the Community Arts Center will primarily be provided by Art Lab, the arts programming arm of the Rebuild Foundation, one of the partners of the developer, Dorchester Artist, LLC. It is anticipated that the Arts Center will offer a variety of programming choices utilizing all forms of visual arts, including photography, drawing, painting, ceramics and video as a primary way of engaging with the community.

The total project cost is approximately \$10.84 million. Funding sources are expected to include private equity, the Chicago Housing Authority, the Federal Home Loan Bank, Low Income Housing Tax Credits and Donation Tax Credits.

## **ACCESS/CIRCULATION**

Vehicular access to the site will remain from the public alley. All existing buildings will have direct pedestrian access from the street frontage. The project will provide 32 accessory parking spaces. The Community / Arts Center will have four assigned on-site parking spaces and the remaining spaces will be available to the residents of the development.

## **SUSTAINABILITY & LANDSCAPE**

This project will meet the requirements of the City of Chicago's Sustainable Matrix by achieving a 50% green roof (1,342 square feet) over the net roof area of the community/ arts center and achieve building certification for the remaining buildings. The project is an adaptive reuse of several existing buildings. The applicant has agreed to be in substantial compliance with the City of Chicago's Landscape Ordinance.

**BULK/USE/DENSITY**

The proposed development has a maximum F.A.R of 0.75. The allowed maximum height for the project will remain the same as the two story structures are existing and are not to increase in height. The proposed amendment will decrease the dwelling units from 36 units to 32 units and reduce the accessory parking spaces to 32 through out the planned development. The residential uses will remain and a use for the Community / Art Center will be added to the planned development.

**RECOMMENDATION**

The Department of Housing and Economic Development has reviewed the project materials submitted by the Applicant and have concluded that the proposed development would be appropriate for the site for the following reasons:

- 1) The project meets the criteria and objectives set forth in Section 17-8-0900 of the Zoning Ordinance and its adoption would not have any adverse impact on the public's health, safety, or welfare as it includes the redevelopment of underutilized buildings while providing affordable rental units and recreational uses for the South Shore Community area.
- 2) The public infrastructure facilities and city services will be adequate to serve the proposed development at the time of occupancy.
- 3) The proposed Planned Development has been reviewed by the Chicago Department of Transportation's and all requested changes have been made.
- 4) Copies of this application have been circulated to other City departments and agencies and no comments have been received; and
- 5) The project will comply with the requirements for access in case of fire and other emergencies;

Based on the foregoing, it is the recommendation of the Department of Housing and Economic Development that the revised application for an amendment to Residential Planned Development No. 239 be approved and the recommendation to the City Council Committee on Zoning, Landmarks and Building Standards be "As-Revised, Passage Recommended".



*Plan of Development Statements.*

1. The area delineated herein as Residential Planned Development Number 239, as amended (the "Planned Development") consists of a net site area of approximately sixty two thousand one hundred and fifty-two (62,152) square feet one and forty three hundredths (1.43) acres of property which is depicted on the attached Planned Development Boundary and Property Line Map ("Property") and is owned or controlled by the Applicant, Dorchester Artist, LLC, an Illinois limited liability company (the "Applicant").
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined section 17-8-0400 of the Zoning Ordinance.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assignees or grantees. Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Housing and Economic Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation. All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

Boundary and Property Line Map; a Site Plan; Green Roof Plan and Elevations; all prepared by Landon Bone Baker Architects, dated February 16, 2012. Full-sized copies of the drawings are on file with the Department of Housing and Economic Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Chicago Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses are permitted in the area delineated herein as Planned Development 239, as amended: multi-unit residential; townhouses; community center; art gallery as an accessory use; recreational uses; residential supportive services; parking and accessory uses.
6. On-Premise signs and temporary signs such as construction and marketing signs shall be permitted within the Planned Development subject to the review and approval of the Department of Housing and Economic Development.
7. In addition to the maximum height of the improvements and any appurtenance in accordance with the Bulk Regulations and Data Table attached hereto, the height of the improvements shall also be subject to limitations approved by the Federal Aviation Administration.
8. The maximum permitted floor area ratio (F.A.R.) for the site shall be in accordance with the attached Bulk Regulations and Data Table. For purposes of floor area ratio ("FAR") calculations, the definitions of the Chicago Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 62,152 square feet.
9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Housing and Economic Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
10. The Site and Landscape plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Housing and Economic Development. Notwithstanding the foregoing, in lieu of landscaping islands in the vehicular use areas, the Applicant will provide landscaping within the courtyard area adjacent to the vehicular use areas subject to review and approval of the Department of Housing and Economic Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.

11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Environment and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.
12. The terms and conditions of development under this the Planned Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
14. The applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. At the time of a hearing before the Chicago Plan Commission, all developments must be in compliance with the current City of Chicago Sustainable Development Policy set forth by the Department of Housing and Economic Development.
15. This Planned Development shall be governed by Section 17-13-0612 of the Zoning Ordinance. Should this Planned Development ordinance lapse, the Commissioner of the Department of Housing and Economic Development shall initiate a Zoning Map Amendment to rezone the property to the original Planned Development 239.

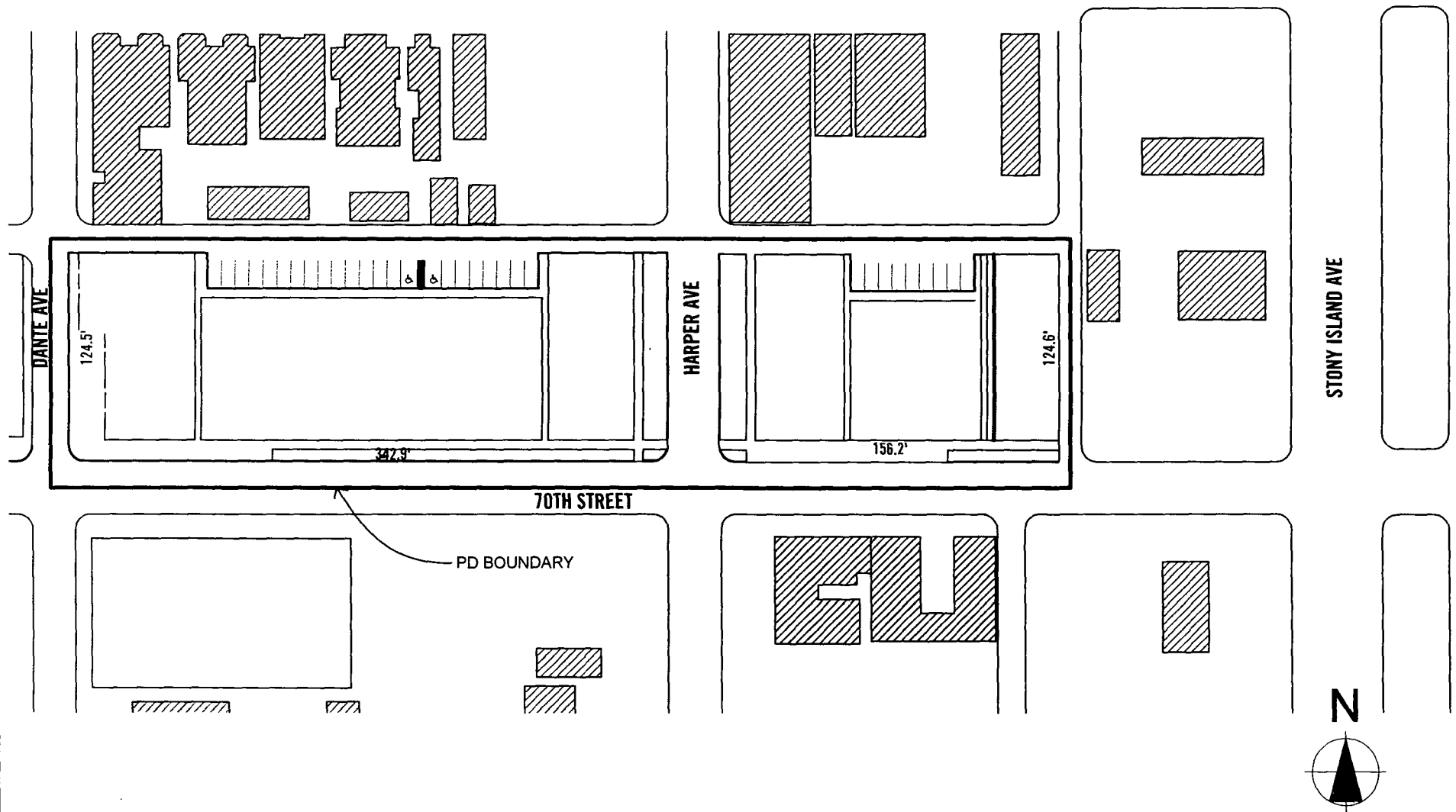
