Grant(s) of privilege in public way for Lakeview Ace Hardware, Inc. Committee on Transportation and Public Way

Committee(s) Assignment:

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to LAKEVIEW ACE HARDWARE, INC., upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, a portion of the public right-of-way for occupation of space/display of merchandise adjacent to its premises known as 3921 N. Sheridan Rd..

Area (A) shall measure eighteen (18) feet in length and four (4) feet in width and used for display of seasonal merchandise during business hours.

Area (B) shall measure ten (10) feet in length and two (2) feet in width and is used for a beach.

Area (C) shall measure nine (9) feet in length and four (4) feet in width and used for display of seasonal merchandise during business hours.

This grant of privilege has been a pre-existing use.

Grantee must allow at least six (6) feet of clear and unobstructed space for pedestrian passage at all times.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1098734 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 11/15/2011.
