Grant(s) of privilege in public way for Bucktown Wicker Park Library Committee on Transportation and Public Way

Committee(s) Assignment:

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to BUCKTOWN WICKER PARK LIBRARY, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, Irrigation System under the public right-of-way for beautification purposes adjacent to its premises known as 1708-10 N. Hoyne Ave.. Existing irrigation system runs under the public alley to extend irrigation lines for landscaping areas from the library building located at 1701 North Milwaukee Avenue to a landscaped garden at 1716 North Hoyne Avenue.

Said Irrigation System(s) at Public Alley at 1708-1710 N. Hoyne Ave. measure(s): One (1) at twenty-two (22) feet in length, and five (5) feet in width for a total of one hundred ten (110) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1098828 herein granted the sum of zero (\$.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 04/26/2011.
