BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No.5-G in the area bounded by

a line 79 feet north of and parallel to West Wisconsin Street; North Halsted Street; a line 54 feet north of West Wisconsin Street; and the alley next west of and parallel to North Halsted Street,

to those of a B1-1 Neighborhood Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


