BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance is hereby amended by changing all of the RS3 Residential Single—Unit
(Detached House) District symbols as shown on Map No. 14-H
in the area bounded by:

A line 217.12 feet South of and parallel to West 62nd Street; a public alley next East of and parallel to South Seeley Avenue; a line 247.12 feet South of and parallel to West 62nd Street; South Seeley Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District


