#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No.13-I in the area bounded by

a line 115 feet north of and parallel to West Ainslie Street, as measured along North Western Avenue; North Western Avenue; a line 40 feet north of and parallel to West Ainslie Street (as measured along North Western Avenue), North Lincoln Avenue

to those of a B1-1Neighborhood Shopping District and a corresponding use district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.


