BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B3-2 Community Shopping District symbols and indications as shown on Map No.11-H in the area bounded by

a line 149.03 feet north of and parallel to West Belle Plaine Avenue; the alley next east of and parallel to North Western Avenue; a line 124.03 feet north of and parallel to West Belle Plaine Avenue; and North Western Avenue.

to those of a B3-3 Community Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
